## GOVERNMENT ACCOUNTABILITY TASK FORCE SUBCOMMITTEE MEETINGS

**PIERRE** – The Government Accountability Task Force is holding subcommittee meetings in Rapid City and Sioux Falls to receive public input on state campaign finance limits and reporting requirements. The Task Force subcommittee will be taking testimony on Monday, September 11 from 5:00 to 7:00 p.m. (MST) at the Event Center at Western Dakota Tech, Rapid City, and on Tuesday, September 12 from 5:00 to 7:00 p.m. (CST) at the Sullivan Health Center, Room 257 at Southeast Tech, Sioux Falls.

The Task Force was created in 2017 by Senate Bill 171 and has the responsibility to examine the issues of campaign finance, and review current related statutory provisions and recent legislative changes. The Task Force is chaired by Senator Jordan Youngberg from Madison, South Dakota.
