RULES REVIEW COMMITTEE TO MEET

PIERRE – The Rules Review Committee, chaired by Representative Jean Hunhoff (R-Yankton), will meet on Tuesday, November 20, 2018, at 9:00 a.m. (CT) in Room 414 of the State Capitol in Pierre, South Dakota.
