#### Executive Order:

The Governor has signed **Executive Order 2017-09**, dated November 6, 2017. SDCL § 49-28A-3 and 49 CFR Part 395 of the U.S. Department of Transportation Federal Motor Carrier Safety Regulations regulate the transportation requirements for drivers of propane transport vehicles. South Dakota is facing extremely low inventories and outages of propane and the return of normal supply flows to fuel terminals in the state is unknown. Transportation of the product is necessary to continue agricultural and heating functions in South Dakota. This executive order declares a

state of emergency in South Dakota and directs that transportation and delivery of propane into and within South Dakota is exempt from 49 CFR Part 395 through November 20, 2017, so long as a driver has had adequate rest and meets all other necessary requirements of the U.S. Department of Transportation Federal Motor Carrier Safety Regulations.
