Transferred general funds from the University of South Dakota, University of South Dakota School of Medicine, South Dakota State University Extension, Agricultural Experiment Station, South Dakota School of Mines and Technology, Black Hills State University, and Dakota State University to the Central Office, South Dakota State University, Northern State University, South Dakota School for the Deaf, and South Dakota School for the Blind and Visually Impaired. This is a base transfer from personal services to personal services. This realigns the salary policy pool adopted during the 2015 Legislative Session in accordance with the Governor's recommended budget. While this transfer moves funds between institutions, the funds being transferred are a redistribution of the salary policy pool, thus the Board of Regents and Bureau of Finance and Management believe the funds are not subject to the provisions of SDCL 4-8A-8.
