Transferred \$350,000 in general funds within State Radio. Transferred \$20,000 in federal fund expenditure authority to other fund expenditure authority within Emergency Services and Homeland Security. Transferred \$184,000 in federal fund expenditure authority to other fund expenditure authority from Emergency Services and Homeland Security to Highway Patrol. Transferred \$16,000 in other fund expenditure authority within Highway Patrol. This is a base transfer from personal services to operating expenses and operating expenses to operating expenses. The transfer of general funds within State Radio will be used for the consolidation of Pierre Radio with the Central SD Communications Center. The funds are available due to vacancies and staffing changes. The transfer of federal fund expenditure authority to other fund expenditure authority within Emergency Services and Homeland Security will be used to allow the Fire Marshalls office to continue with firefighter essential grants, the smoke detector program, and other fire safety training grants. The transfer of federal fund expenditure authority to other fund expenditure authority from Emergency Services and Homeland Security to Highway Patrol and other fund expenditure authority within Highway Patrol will be used to continue the Motorcycle Safety Funds BRC/ERC incentive program, increase safety/educational campaigns for the Sturgis Rally and safety/educational campaigns for ATVs.
