Thank you for your response to my September 15, 2008, letter.

Our main goal is to ensure electrician licensing reciprocity between South Dakota and North Dakota. Please be assured the items listed in your September 19, 2008, letter do not affect our reciprocity agreement. These are situations unique to South Dakota in which our legislature has found it necessary to create Codified Laws and/or Administrative Rules to address certain issues. These items are not related to licensure and, therefore, have no impact on North Dakota.

We would not presume to suggest changes to North Dakota law on issues that do not impact South Dakota citizens and we hope you will offer us the same courtesy. I welcome the opportunity to further discuss questions regarding licensure and reciprocity with you if needed.
