1 FOR AN ACT ENTITLED, An Act to clarify, repeal, update, and make form and style revisions
2 to certain statutes related to the Department of Transportation.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 1-44-4 be amended to read as follows:

5 1-44-4. ~~The State Transportation Commission, formerly designated the Board of~~
6 ~~Transportation, is abolished.~~ There is created the Transportation Commission within the
7 Department of Transportation. The Transportation Commission ~~shall consist~~ consists of nine
8 members. ~~Eight of the members shall be appointed by the Governor and the ninth member shall~~
9 ~~be appointed by the Governor from area 3 as defined in § 1-44-5. His term shall be for four~~
10 ~~years and begin on April 19, 1987, and expire on April 18, 1999.~~ The Governor shall appoint
11 the members. All members ~~shall be~~ are full voting members of the commission. Not all
12 members of the commission may be from the same political party. No two ~~appointive~~ members
13 may at the same time be a resident of the same county.

14 Section 2. That § 1-44-6 be amended to read as follows:

15 1-44-6. Terms of members of the Transportation Commission ~~shall be~~ are four years. ~~The~~
16 ~~terms of members of the Transportation Commission who are first appointed after April 18,~~



1 1983, shall be: two appointed for a term of one year; two appointed for a term of two years; two
2 appointed for a term of three years; and two appointed for a term of four years, and such initial
3 terms shall be designated by the Governor. Any member appointed to fill a vacancy arising from
4 other than the natural expiration of a term shall serve for only the unexpired portion of the term.

5 Section 3. That § 1-44-7 be amended to read as follows:

6 1-44-7. The Transportation Commission shall annually elect from its members such officers
7 as it deems advisable. A majority of the commission members shall constitute a quorum. The
8 commission shall exercise such functions as are transferred to it provided by this chapter and
9 such other functions as may be assigned to it by law. The commission shall hold meetings at the
10 call of the ~~chairman~~ chair or a majority of the members.

11 Section 4. That § 1-44-7.1 be repealed.

12 ~~1-44-7.1. The Transportation Commission shall perform all statutory and other functions of~~
13 ~~the former State Transportation Commission including all quasi-legislative, quasi-judicial,~~
14 ~~advisory, and special budgetary functions as defined by law.~~

15 Section 5. That § 1-44-8 be amended to read as follows:

16 1-44-8. Notwithstanding other provisions of this title, the Transportation Commission shall;
17 ~~subject to the limitations provided herein and by law, have~~ has final authority within the
18 Department of Transportation over the allocation of all funds for the construction of
19 transportation facilities.

20 Section 6. That § 1-44-13 be repealed.

21 ~~1-44-13. The Department of Transportation shall, under the direction and control of the~~
22 ~~secretary of transportation, perform all the functions of the former Department of Highways~~
23 ~~created by chapter 31-2, subject to such changes as specified in §§ 1-44-14 and 1-44-16.~~

24 Section 7. That § 1-44-14 be repealed.

1 ~~1-44-14. The Department of Transportation shall, under the direction and control of the~~
2 ~~secretary of transportation, perform all the functions of the former State Highway Commission~~
3 ~~created by chapter 31-2, except that the Transportation Commission shall perform the other~~
4 ~~quasi-legislative, quasi-judicial, advisory, and special budgetary functions (as defined in § 1-32-~~
5 ~~1) of the State Highway Commission.~~

6 Section 8. That § 1-44-14.1 be repealed.

7 ~~1-44-14.1. The functions exercised by the accident record program pursuant to chapters 32-~~
8 ~~12 and 32-34 are transferred from the Department of Commerce and Regulation to the~~
9 ~~Department of Transportation.~~

10 ~~The functions exercised by the secretary of commerce and regulation pursuant to chapters~~
11 ~~32-12 and 32-34 are transferred to the secretary of transportation.~~

12 Section 9. That § 1-44-25 be amended to read as follows:

13 1-44-25. The South Dakota State Railroad Board is created. The board ~~shall consist~~ consists
14 of seven members to be appointed by the Governor. Members shall serve a four-year term. No
15 more than five members may be of the same political party. ~~The terms of members of the South~~
16 ~~Dakota State Railroad Board who are first appointed after March 13, 1980, shall be: two~~
17 ~~appointed for a term of one year; two appointed for a term of two years; two for a term of three~~
18 ~~years; and one for a term of four years, and such initial terms shall be designated by the~~
19 ~~Governor.~~ Any member appointed to fill a vacancy arising from other than the natural expiration
20 of a term shall serve only for the unexpired term, but may be reappointed to a full term. The
21 board shall annually choose from its membership a chairman chair, a vice-chairman vice-chair,
22 and a secretary-treasurer. No member may be removed from office except for cause.

23 Section 10. That § 31-1-1 be amended to read as follows:

24 31-1-1. Every way or place of whatever nature open to the public, as a matter of right, for

1 purposes of vehicular travel, is a highway. The term "highway" shall not be deemed to, highway,
2 does not include a roadway or driveway upon grounds owned by private persons, colleges,
3 universities, or other institutions, but such term ~~may be deemed to include~~ includes a roadway
4 or driveway upon grounds owned by any state agency, college, university, or institution if the
5 governing agency, board, or commission by resolution so determines and the Department of
6 Transportation concurs ~~therein~~.

7 Section 11. That § 31-1-2 be amended to read as follows:

8 31-1-2. Bridges and culverts erected or maintained by the public constitute a part of the
9 public highway. The word, road or highway, whenever used in this title ~~shall be construed to~~
10 ~~include bridges~~ includes any bridge upon or which form a part of the road or highway
11 constructed, maintained, or to be improved; also ~~subways~~ any subway or ~~underpasses~~ underpass
12 and any overhead crossings crossing.

13 Section 12. That § 31-2-8 be repealed.

14 ~~31-2-8. The state highway engineer and his assistants shall be provided with suitable offices~~
15 ~~and drafting rooms.~~

16 Section 13. That § 31-2-18 be amended to read as follows:

17 31-2-18. The Department of Transportation ~~is hereby authorized to~~ may contract for the
18 services of ~~mentally retarded persons~~ any person with a developmental disability as defined in
19 chapter 27B-1, for the performance of any work under the supervision and control of ~~said the~~
20 department, without competitive bids, ~~whenever~~ if the department ~~shall determine~~ determines
21 that ~~any such the~~ work can be performed by ~~said mentally retarded persons~~ the person with a
22 developmental disability at a cost substantially equal to the ordinary cost ~~thereof~~.

23 Section 14. That § 31-2-39 be amended to read as follows:

24 31-2-39. No execution ~~shall~~ may issue against the state on any final judgment obtained

1 under the provisions of this chapter; ~~but whenever.~~ However, if final judgment against the state
2 ~~shall have~~ has been obtained in any such action as ~~herein provided~~ by this chapter, the clerk of
3 the court, wherein the final judgment was obtained, shall forthwith; send a certified copy of ~~said~~
4 the judgment by registered or certified mail to the secretary of transportation, and to the state
5 auditor; ~~and the.~~ The auditor shall ~~thereupon~~ audit the amount of damages and costs therein
6 finally awarded; ~~and the same shall be paid.~~ The state treasurer shall pay the damages and costs
7 out of the state highway fund ~~by the state treasurer.~~

8 Section 15. That § 31-4-2 be repealed.

9 ~~31-4-2. All rights-of-way of the state trunk highway system, together with all appurtenance~~
10 ~~thereto, the right or interest in or to which was or is in any county shall be and the same are~~
11 ~~hereby transferred to and vested in the State of South Dakota for highway purposes.~~

12 Section 16. That § 31-4-5 be amended to read as follows:

13 31-4-5. ~~Whenever~~ If any state trunk highway ~~shall include the~~ includes a connecting street
14 ~~or streets~~ within a municipality over twenty-five hundred population, the Department of
15 Transportation shall ~~be charged with the maintenance of such streets but~~ maintain the street.
16 However, the snow removal from ~~same shall be~~ the street is the duty of the first or second class
17 municipality within whose boundaries ~~they lie~~ the street lies.

18 Section 17. That § 31-4-6 be amended to read as follows:

19 31-4-6. No change ~~shall~~ may be made so that the state trunk highway system ~~shall cease~~
20 ceases to interconnect every county seat or to connect every first or second class municipality
21 having a population of twenty-five hundred or more by the last federal census.

22 Section 18. That § 31-4-8 be amended to read as follows:

23 31-4-8. The ~~Department of Transportation is hereby authorized to~~ department may reroute
24 portions of the state trunk highway system onto the national system of interstate highways. The

1 department is ~~authorized to~~ may delete portions of the state trunk highway system ~~where same~~
2 if they have been rerouted onto the national system of interstate highways where feasible and
3 in the best interest of the State of South Dakota.

4 Section 19. That § 31-4-9 be repealed.

5 ~~— 31-4-9. The Department of Transportation of the State of South Dakota is hereby authorized~~
6 ~~and empowered to enter into contracts with the United States of America fixing the terms and~~
7 ~~conditions under which that part of the state trunk highway system which it is found necessary~~
8 ~~to relocate, rearrange, or alter in order to facilitate the construction of the dams and reservoirs,~~
9 ~~within the State of South Dakota, by the United States government in the development of the~~
10 ~~Missouri River flood control projects, will be made.~~

11 Section 20. That § 31-4-10 be repealed.

12 ~~— 31-4-10. Any contract entered into pursuant to § 31-4-9 shall provide for reimbursement of~~
13 ~~the State of South Dakota by the United States of America for all works performed and~~
14 ~~materials furnished under said contract by the state and for all costs incurred prior to execution~~
15 ~~of said contract or contracts in connection with preliminary investigations, studies, plans, and~~
16 ~~estimates in furtherance of the contract or contracts.~~

17 Section 21. That § 31-4-11 be repealed.

18 ~~— 31-4-11. The Department of Transportation, in order to expeditiously carry out the terms of~~
19 ~~any contract or contracts pursuant to § 31-4-9, is authorized by resolution to make changes in~~
20 ~~the location of any part of the state trunk highway system necessary, to comply with said~~
21 ~~contract, and said changes are hereby authorized to be made without recourse to notice and~~
22 ~~hearing as provided by the general statute for changes in the state trunk highway system.~~

23 Section 22. That § 31-4-12 be repealed.

24 ~~— 31-4-12. The Department of Transportation, in order to expeditiously carry out the terms of~~

1 ~~any contract or contracts pursuant to § 31-4-9, is authorized to purchase rights-of-way and make~~
2 ~~surveys for the necessary projects and to let all contracts for the construction of the projects~~
3 ~~necessary to such relocations, rearrangements, or alterations in the same manner as now~~
4 ~~provided for federal aid and state aid projects.~~

5 Section 23. That § 31-4-14 be amended to read as follows:

6 31-4-14. All marking, surveying, construction, repairing, and maintenance of the state trunk
7 highway system ~~shall be~~ is under the control and supervision of the ~~Department of~~
8 ~~Transportation, and the~~ department. ~~The~~ department shall ~~be charged with the administration~~
9 ~~of~~ administer the laws relative thereto.

10 Section 24. That § 31-4-15 be repealed.

11 ~~—31-4-15. Any action by the governing body of any municipal corporation, the board of~~
12 ~~supervisors of any township, or the board of county commissioners of any county, having the~~
13 ~~effect of discontinuing, relocating, or altering the location or route of any highway forming a~~
14 ~~part of the state trunk highway system, shall be null and void.~~

15 Section 25. That § 31-5-1 be amended to read as follows:

16 31-5-1. The Department of Transportation shall maintain, and keep in repair, all highways
17 or portions of highways, including the bridges and culverts thereon, ~~which highways have been~~
18 ~~constructed or improved by the department and are on the state trunk highway system.~~

19 Section 26. That § 31-5-2 be repealed.

20 ~~—31-5-2. The Department of Transportation may at its option, maintain and keep in repair~~
21 ~~such other portions of the state trunk highway system which have not been constructed or~~
22 ~~improved by the Department of Transportation, or the construction or improvement of which~~
23 ~~has not been paid for in whole or in part by the state or federal aid.~~

24 Section 27. That § 31-5-3 be repealed.

1 ~~31-5-3. The Department of Transportation is hereby empowered to cause the maintenance~~
2 ~~and repair work provided for in §§ 31-5-1 and 31-5-2 to be performed by day labor, or by~~
3 ~~convict labor, or by contract, or by agreement with the board of county commissioners, and if~~
4 ~~such work is done by contract, such contract may be let with or without competitive bids as the~~
5 ~~department may determine.~~

6 Section 28. That § 31-5-4 be repealed.

7 ~~31-5-4. The Department of Transportation may rent, hire, or purchase the necessary tools,~~
8 ~~machinery, and equipment for the performance of the maintenance and repair work provided for~~
9 ~~in §§ 31-5-1 and 31-5-2.~~

10 Section 29. That § 31-5-5 be amended to read as follows:

11 31-5-5. The ~~Department of Transportation~~ department may enter into ~~agreements with~~
12 ~~counties, which agreements may~~ an agreement with any county to provide that each may
13 perform work or submit monetary contributions for the completion or improvement of a certain
14 part of the state trunk highway within ~~such respective~~ the county.

15 Section 30. That § 31-5-7 be repealed.

16 ~~31-5-7. All moneys heretofore allotted or to be hereafter allotted to the state from the federal~~
17 ~~government as federal aid for roads, shall be expended by the Transportation Commission on~~
18 ~~the type of highway designated as provided by the terms of the allotment.~~

19 Section 31. That § 31-5-8 be amended to read as follows:

20 31-5-8. All moneys levied and collected by the state by general state taxation for state
21 highway purposes, or received from the sale of bonds, or appropriated for state highway
22 purposes, shall be expended only in the laying out, marking, constructing, reconstructing, or
23 maintaining public highways forming the trunk highway system ~~except such sums as are~~
24 required. However, such moneys may only be used for the maintenance of the Transportation

1 Commission as provided in chapter 31-2, ~~and except that.~~ In addition, twenty-five percent of
2 all such ~~funds~~ moneys accruing to the state highway fund, other than from federal funds, shall
3 be at the disposal of the ~~Department of Transportation~~ department in marking, constructing,
4 reconstructing, repairing, or maintenance of highways of the state.

5 Section 32. That § 31-5-9 be repealed.

6 ~~—31-5-9. The Department of Transportation shall determine the improvements to be made~~
7 ~~upon the trunk highway system during any year or years.~~

8 ~~—Immediately upon the determination to make certain improvements upon the trunk highway~~
9 ~~system the department shall cause a survey to be made and complete plans and data to be~~
10 ~~prepared.~~

11 Section 33. That § 31-5-11 be amended to read as follows:

12 31-5-11. Payments from all funds made available for road and bridge construction contracts
13 for the trunk highway system shall be made from time to time by the state treasurer upon
14 estimates approved by the ~~state highway engineer~~ department. Upon partial payments made
15 upon signed contracts, the approval of the ~~state highway engineer~~ department on such partial
16 payment vouchers is sufficient proof of ~~the correctness of the same~~, and the oath of the payee
17 is not required in this case.

18 Section 34. That § 31-5-12 be repealed.

19 ~~—31-5-12. The Department of Transportation may arrange to have the work done by day labor,~~
20 ~~convict labor, or arrangement with the board of county commissioners, and may use the county~~
21 ~~forces and machinery.~~

22 Section 35. That § 31-5-13 be repealed.

23 ~~—31-5-13. The boards of county commissioners are authorized to bid for the county upon~~
24 ~~work in their respective counties or may enter into contract with the state, without submitting~~

1 ~~competitive bids at advertised lettings.~~

2 Section 36. That § 31-5-14 be repealed.

3 ~~—31-5-14. The board of county commissioners of any county is authorized to cooperate with~~
4 ~~the Department of Transportation in the construction and maintenance of the state trunk~~
5 ~~highway system lying within its county and to use and expend funds from its county road fund~~
6 ~~for that purpose.~~

7 Section 37. That § 31-5-15 be repealed.

8 ~~—31-5-15. The Department of Transportation may purchase machinery, equipment, surplus~~
9 ~~war materials and arrange with local governments or contractors to use any machinery so~~
10 ~~obtained by the department, according to such terms as may be agreed to by the Transportation~~
11 ~~Commission. Money received from rental or sale of machinery or other surplus war materials~~
12 ~~or for freight or other charges shall be deposited with the state treasurer and credited to the state~~
13 ~~highway funds.~~

14 Section 38. That § 31-5-17 be repealed.

15 ~~—31-5-17. The Department of Transportation shall keep a detailed set of books and accounts,~~
16 ~~showing the expenditures by it and coming under its charge and supervision, and the amounts~~
17 ~~available for construction and maintenance work in each of the several counties.~~

18 Section 39. That § 31-5-19 be amended to read as follows:

19 31-5-19. To more effectually preserve the historical, archaeological, and paleontological
20 remains of the state, the ~~Department of Transportation is authorized to~~ department may enter
21 into agreements with the appropriate agencies of the state charged with preserving historical,
22 archaeological, and paleontological remains to have these agencies remove and preserve such
23 remains disturbed or to be disturbed by highway construction and to use highway funds, ~~when~~
24 if appropriated, for this purpose. This authority specifically extends to highways which are part

1 of the National System of Interstate and Defense Highways as defined in the Federal Aid
2 Highway Act of 1956, Public Law 627, 84th Congress, and the use of state funds on a matching
3 basis with such federal funds ~~therein~~.

4 Section 40. That § 31-6-1 be amended to read as follows:

5 31-6-1. In order that the state may, through ~~its~~ the Department of Transportation, more fully
6 cooperate with the federal government in its program for extending aid in construction of certain
7 roads designated by Title 23, United States Code, ~~and acts amendatory thereof~~ as secondary
8 roads, ~~the Department of Transportation is hereby authorized and empowered to~~ department
9 may participate and assist in ~~said~~ the program to the extent ~~hereinafter~~ provided by this chapter.

10 Section 41. That § 31-6-2 be amended to read as follows:

11 31-6-2. ~~The Department of Transportation is hereby authorized and empowered to~~
12 department may cooperate with the various boards of county commissioners, and other
13 appropriate local road officers of the state, and the Federal Highway Administration, in the
14 selection of a system of secondary roads as set out in Title 23, United States Code, and to submit
15 to the Federal Highway Administration in the same manner as other federal aid projects are now
16 submitted, projects for improving any roads on the principal secondary roads, rural free delivery
17 mail, and public school bus routes, either outside of municipalities or inside of municipalities
18 of less than five thousand population, and which are not on the federal aid primary highway
19 system or state trunk highway system.

20 Section 42. That § 31-6-3 be amended to read as follows:

21 31-6-3. Before any project under the provisions of this chapter may be submitted to the
22 Federal Highway Administration, a request for the submission of the project shall be embodied
23 in a resolution passed by the governing body of the county having control of the highway upon
24 which the project is desired, and a certified copy of same filed with the ~~Department of~~

1 ~~Transportation~~ department, together with an agreement by the county to reimburse the
2 ~~Department of Transportation~~ department for any costs over and above those costs covered by
3 the federal-aid secondary funds available to the county plus the state highway funds matching
4 those federal-aid secondary funds to carry out ~~said~~ the project to the beginning of construction.
5 However, if the county petitioning for the project desires to use its own highway organization
6 for the making of ~~such~~ the preliminary survey, plans, and estimates, ~~it~~ the county may do so, but
7 ~~same~~ the survey, plans, and estimates shall be submitted in detail to the ~~Department of~~
8 ~~Transportation~~ department for approval.

9 Section 43. That § 31-6-4 be amended to read as follows:

10 31-6-4. In case any secondary road project is approved by the Federal Highway
11 Administration, the ~~Department of Transportation~~ department may call for bids and let a
12 contract for the work in the same manner as now provided for federal aid projects, ~~provided,~~
13 ~~however, that no such.~~ However, no contract ~~shall~~ may be let until the county having
14 jurisdiction of ~~said~~ the highway, ~~shall have~~ has fully and legally provided for the payment of any
15 project costs over and above those costs covered by the federal-aid secondary funds available
16 to the county plus the state highway fund matching those federal-aid secondary funds. However,
17 no such contract may be let until the political subdivision under whose jurisdiction the highway
18 upon which the project is to be constructed has entered into a binding agreement to maintain the
19 project when completed at ~~its~~ the subdivision's own cost and expense in such manner as ~~shall~~
20 may be agreeable to the federal highway administration and the ~~Department of Transportation~~
21 department.

22 Section 44. That § 31-6-5 be amended to read as follows:

23 31-6-5. The jurisdiction and control of the highways upon which any ~~said~~ secondary road
24 projects may be approved or constructed, ~~shall be~~ is and shall remain in the county or other

1 political subdivision as it was, and to the extent it was at the time of the setting up of ~~said the~~
2 ~~project save and only that.~~ However, the ~~Department of Transportation shall have power to~~
3 department may enter into a project agreement with the Federal Highway Administration for
4 ~~same,~~ contract for construction of ~~same the project,~~ and ~~shall have full power and authority to~~
5 supervise, control, and oversee the construction of ~~said the~~ project in accordance with their
6 agreement with the Federal Highway Administration.

7 Section 45. That § 31-6-6 be amended to read as follows:

8 31-6-6. The State of South Dakota ~~shall is not be~~ ultimately liable for the costs of any ~~such~~
9 secondary road project not redeemable from public road funds including the state match of those
10 ~~funds but shall act solely.~~ The department shall act as agent for the county affected hereby in
11 submission of said the project, letting of the contract, and the supervision and control of the
12 ~~construction and shall be reimbursed by the.~~ The county originating the project shall reimburse
13 the state for its the state's share of all money expended and not redeemable from federal funds
14 plus state match in bringing same the project to the construction stage regardless of whether or
15 ~~not said the contract is finally let, and the Department of Transportation shall also be reimbursed~~
16 ~~by the.~~ The county requesting said the project shall reimburse the department in case the
17 contract is let for all expenses incurred in supervising or controlling the construction work, and
18 for all money paid out or advanced at any time in carrying out the construction of said the
19 project and not redeemable from federal funds including the state match of those funds.

20 Section 46. That § 31-6-7 be amended to read as follows:

21 31-6-7. Nothing in this chapter ~~contained shall~~ may be construed to bind the State of South
22 Dakota, or the ~~Department of Transportation~~ department to pay the cost of maintenance of ~~said~~
23 ~~projects~~ any secondary road project when completed; ~~it being the intention of this statute to~~
24 ~~place the maintenance cost of said projects upon the.~~ The political subdivision under whose

1 jurisdiction the highway is at the time ~~said~~ maintenance work is required is responsible for the
2 maintenance cost of the project.

3 Section 47. That § 31-6-9 be amended to read as follows:

4 31-6-9. The Transportation Commission shall provide sufficient funds from the state
5 highway fund to match all federal-aid secondary funds used to construct a project under this
6 chapter. ~~This section shall be applicable to federal-aid secondary funds allocated to the counties~~
7 ~~after July 1, 1989.~~

8 Section 48. That § 31-7-1 be amended to read as follows:

9 31-7-1. ~~For the purpose of this chapter~~ Terms used in this chapter mean:

10 (1) "National system of interstate highways," includes all highways that have been or
11 may become eligible for development with funds provided by federal highway acts
12 for use on the interstate system;

13 (2) "Control areas," a control area is a metropolitan area, first or second class
14 municipality, or industrial center, defense installation, a topographic feature such as
15 a mountain pass, a favorable river crossing, a hub road which would result in material
16 traffic increment on the interstate route, a section of completed expressway, or a
17 place on the common boundary of two states agreed to by the states concerned;

18 (3) "Intermediate control points," an intermediate control point is either end of an
19 acceptable section on final location of an interstate route;

20 (4) "Department," the Department of Transportation.

21 Section 49. That § 31-7-2 be amended to read as follows:

22 31-7-2. The ~~Department of Transportation is hereby authorized and empowered to~~
23 department may employ such assistants, agents, engineers, and engineering consultants and to
24 enter into such contractual relations in behalf of the state and to do and perform all such acts as

1 are necessary for the public good agreeable to the provisions of this chapter.

2 Section 50. That § 31-7-3 be amended to read as follows:

3 31-7-3. The ~~South Dakota Department of Transportation~~ department, in cooperation with
4 the Federal Highway Administration of the United States Department of Transportation, or other
5 agencies of the United States government, may locate and construct the South Dakota sections
6 of the National System of Interstate Highways according to American Association of State
7 Highway and Transportation Officials Standards peculiar to that system and shall operate and
8 maintain ~~said~~ the highways as toll-free facilities ~~as hereinafter provided~~.

9 Section 51. That § 31-7-4 be amended to read as follows:
