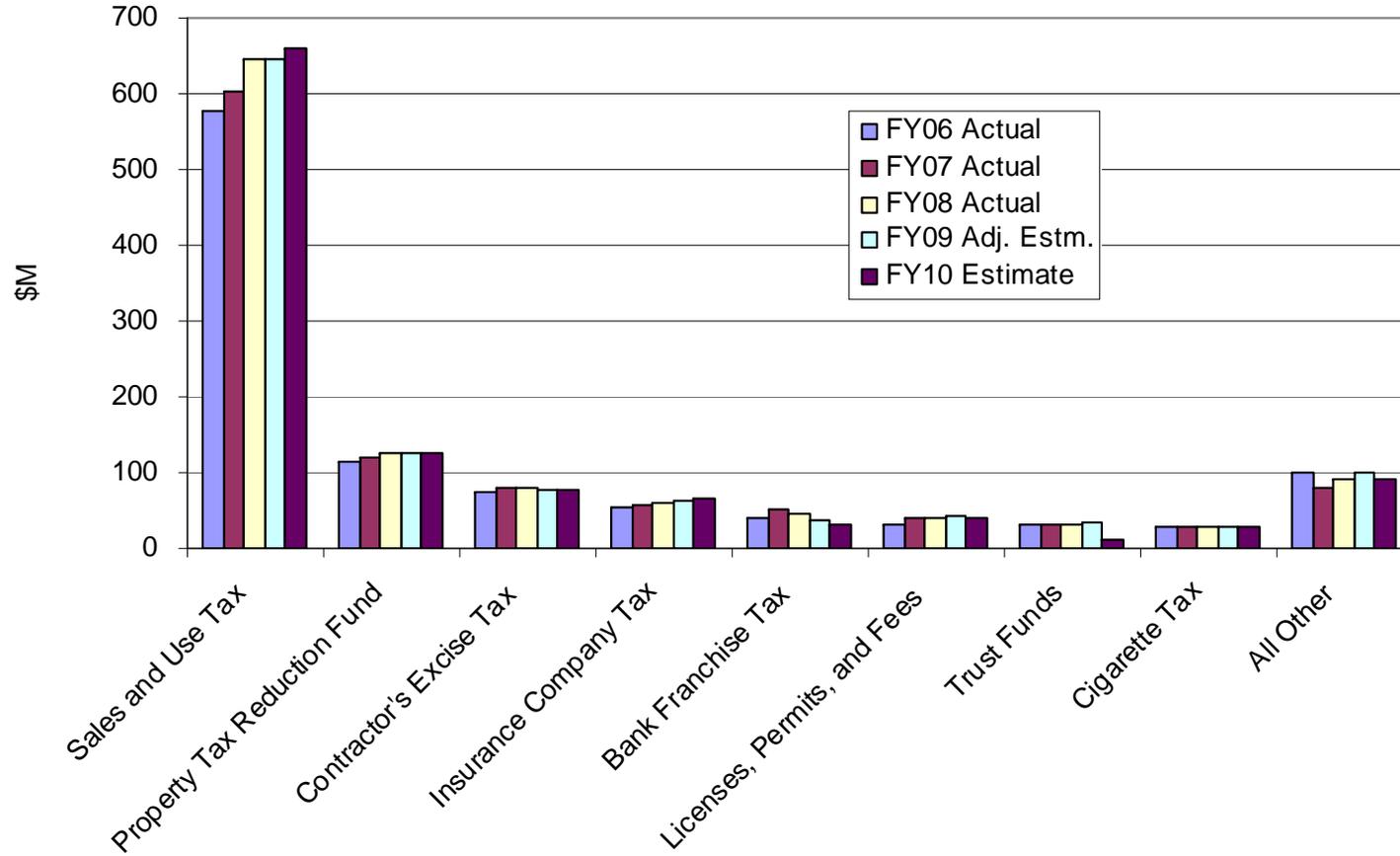

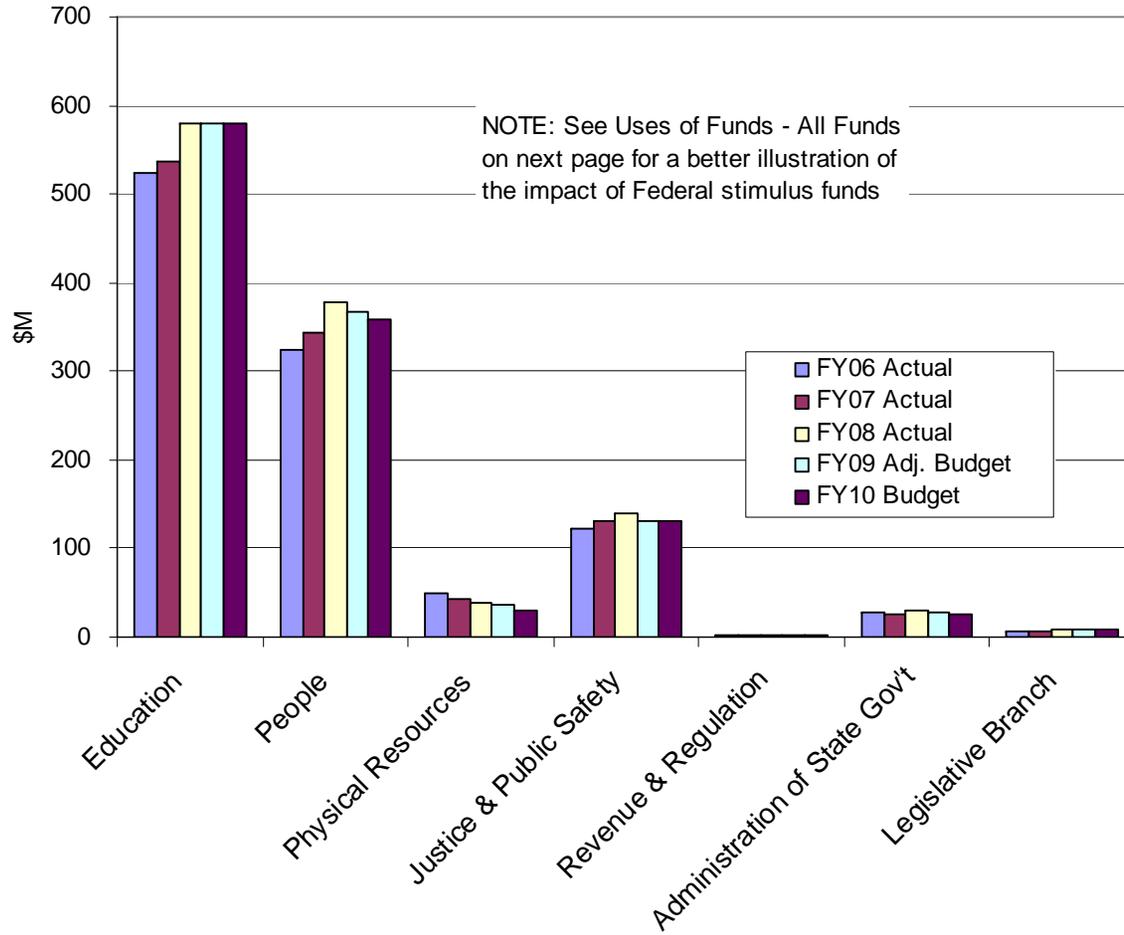

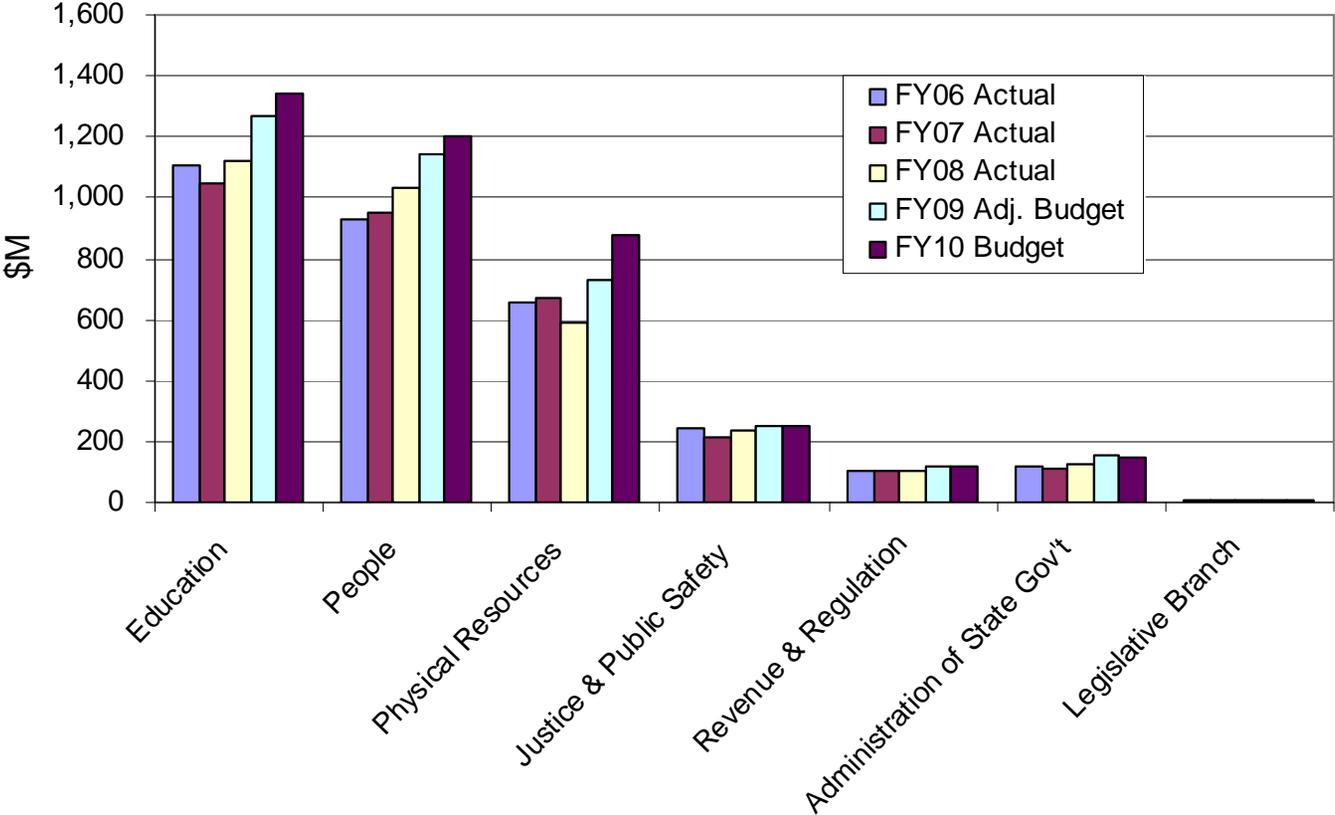
Sources of Funds – General Funds Only



Uses of Funds – General Funds Only

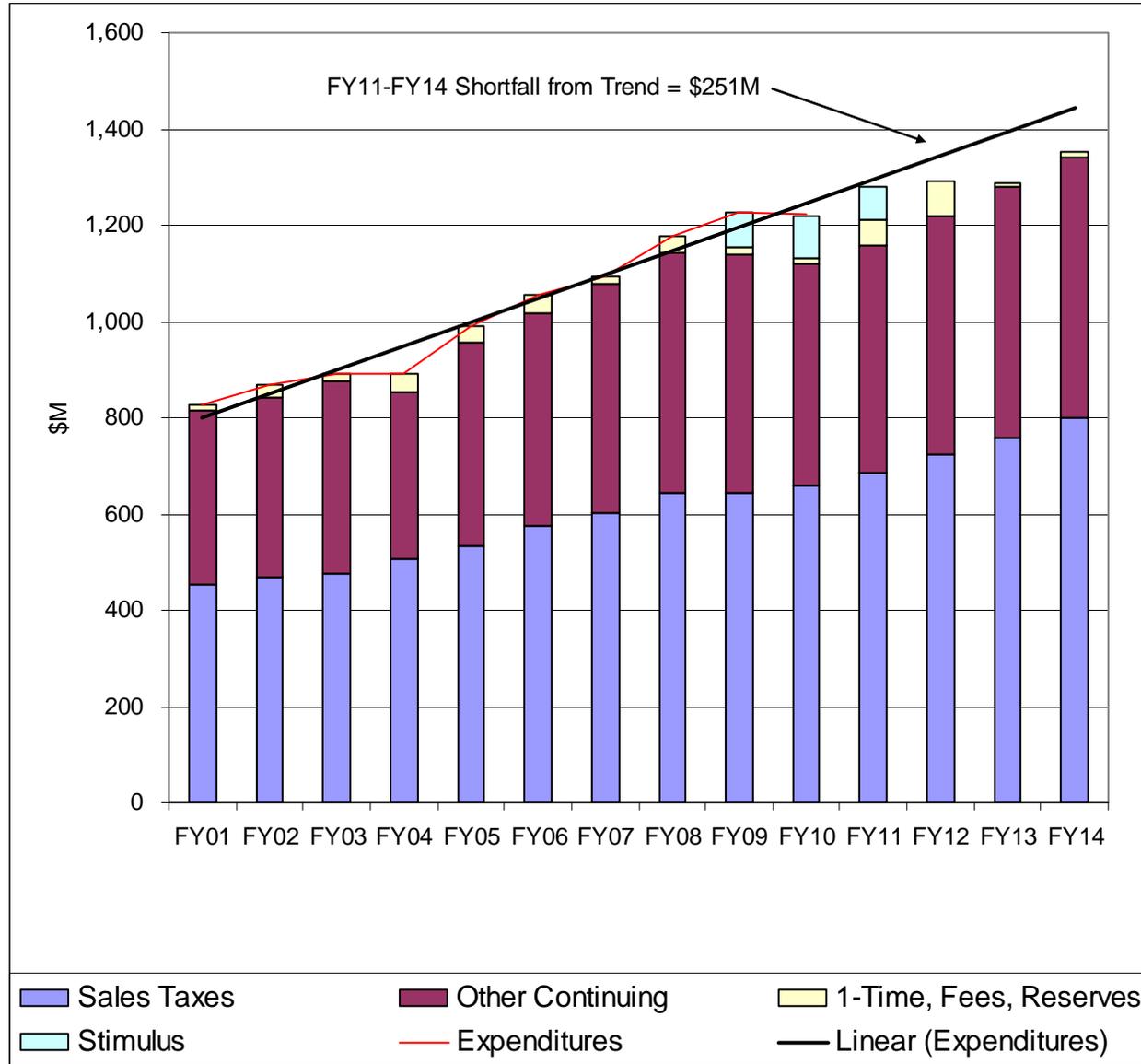


Uses of Funds – All Funds

FY10 Major Budget Items

Education

- **State Aid to General Education:** Increase Per Student Allocation by 3% in the State Aid Formula (\$4,804.60 per student -- \$8.9M total increase).
- **State Aid to Special Education:** No increase in the formula, but the number of Special Education students are expected to increase (\$1.7M GF).
- **Education Enhancement Tobacco Tax Funding:** Repealed the EETTF earmark for education law. The following programs were funded with EETF and were cut:
 - Alternative Education, stipends for National Board Certified Teachers, Career and Technical grants to K-1
- **ESAs:** Repealed the law that earmarked EETT funds for the ESAs - remaining \$500,000 GF can provide match for competitive stimulus grants -- \$1.7M was cut
- **Post Secondary Institutes:** 3% inflationary increase on a per student basis (\$280,285 GF). No additional funding approved.
- **Sparsity:** Reinstated the program with reduced funding through a special appropriation (\$1.7M GF).
- **Masters Degree in Social Work:** Board of Regents will develop a new master's degree program at USD - program cost \$474,500 -- appropriation \$237,251
- **Higher Education Cuts:** Various budgets within the Board of Regents - total cut \$1,970,000 GF
- **Higher Education Cuts:** Maintenance and Repair funding cut \$1,632,999 GF
- **SD School for the Deaf:** All proposed cuts eventually restored, but Legislature will require improvements to services by next session.
- **Stimulus: Birth to Three:** Program was proposed to be cut, but eventually was fully funded. (\$1.85M GF / \$2.7M FF / \$2.1M Stimulus)
- **Stimulus: Education Technology** stimulus grants (\$3,209,375 FF)
- **Stimulus: Homeless Education** stimulus grants to track homeless children (\$106,000 FF)
- **Stimulus: Title I Education** stimulus grants to local school districts (\$34,650,000 FF)
- **Stimulus: Title I NCLB School Improvement** stimulus grants (\$8,933,000 FF)
- **Stimulus: IDEA Part B** stimulus grants (\$15,815,432 FF) These funds could have a positive effect on the Extraordinary Cost Fund, and could possibly be used for deaf students in school districts. A like amount was approved in the FY2009 stimulus package.
- **Stimulus: IDEA Part B Preschool** stimulus grants (\$760,139 FF) The funds are for special education preschool programs. A like amount was approved in the FY2009 stimulus package.
- **Stimulus: School Lunch Equipment** stimulus grants (\$308,000 FF)
- **Stimulus: Emergency Food Assistance Program (TEFAP) School Lunch Program** stimulus grants (\$231,000 FF)
- **Stimulus: Board of Regents Work Study Program** stimulus grants (\$882,000 FF)
- **Stimulus: Board of Regents Pell Grants** stimulus (\$22,168,182 FF)

People

- **Mandatory Provider Inflation:** Increase to certain providers due to federal requirements or the State's Medicaid Plan. (\$3,658,463 GF, \$6,396,687 FF) NOTE: there was no increase for discretionary provider inflation for FY10.
- **Social Services - Adult Services and Aging:** Rebase long term care facilities (\$973,020 GF, \$2,153,650 FF)
- **Social Services - Children's Services:** Increased funding for subsidized guardianships and adoptions. (\$709,243 GF, \$361,695 FF)
- **Catastrophic County Poor Relief:** Administration of this program was shifted to the counties resulting in a decrease of \$600,000 other funds, \$29,055 in federal funds, \$24,109 in general funds and 1.0 FTE.
- **IMT Program-** Increase of \$974,017 and 7.0 FTE for the Intensive Methamphetamine Treatment (IMT) Program. Prior funding was by special appropriations.
- **Stimulus - FMAP (Social Services, Human Services, Corrections, Education):** Increased FMAP rate by 6.2% resulting in a decrease of general funds of \$41,941,331 and an increase in federal funds. (\$42,743,338 FF)
- **Stimulus - Social Services:** Elderly nutrition for congregate meals (2/3) and home delivered meals (1/3). (\$500,000 FF)
- **Stimulus - Social Services:** Increased Child Care Development funds to supplement current child care funding. (\$5,000,000 FF)

FY10 Major Budget Items, cont.

- **Stimulus - Social Services:** The ARRA allows the state to use federal child support incentive funds to match federal Title IV-D child support funds resulting in a decrease of \$1,450,000 in general funds. (\$1,450,000 FF increase)
- **Stimulus - Social Services:** Funding to shelters who serve victims of domestic violence and sexual assault, and to the crime victims' compensation program. (\$590,318 FF)
- **Stimulus - Social Services:** Increased funding for the Community Service Block Grant to be used by the Community Action Programs which provide services to low income families. (\$3,000,000 FF)
- **Stimulus - Social Services - Foster Care and Adoption Services:** Increased Title IV-E federal match funding by 6.2% resulting in a decrease of general funds \$534,786. (\$534,786 FF increase)
- **Stimulus - Social Services:** Additional funds for law enforcement, prosecution, victims' service programs, and the court services. (\$857,968 FF)
- **Stimulus - Social Services - Weatherization:** Increased funding for weatherizing low income homes throughout the state. (\$22,000,000 FF)
- **Stimulus - Social Services - Medicaid:** Avoided the proposed cut in the medicaid budget. (\$2,275,690 GF, \$3,604,915 FF)
- **Stimulus - Health:** Additional funds for Health Information Technology activities. (\$5,000,000 FF)
- **Stimulus - Health:** Additional funds to purchase childhood vaccines. (\$276,935 FF)
- **Stimulus - Human Service:** Additional funds for vocational rehabilitation. (\$720,000 FF)
- **Stimulus - Human Service:** Additional funds for independent living services. (\$246,083 FF)
- **Stimulus - Human Services:** Avoided the proposed cut in the Traumatic Brain Injury program. (\$59,116 GF, \$99,286 FF)
- **Stimulus - Human Services:** Avoided the proposed cut of the Autism Grant. (\$125,000)

Physical Resources

- **Tourism:** Funding flip of \$2,000,000 from general funds to other funds due to passage of HB 1072 which increased the gross receipts tax from 1% to 1 and a 1/2%. It is estimated that the one-half percent increase will generate \$2.6 to \$2.9 million additional revenues.
- **Stimulus - Arts:** Avoided eliminating the office of the arts and 3.0 FTEs. General fund expenditure authority was replaced by \$668,509 of other fund expenditure authority to be funded from the one-half percent increase in the gross receipts tax.
- **Stimulus - Arts:** National Endowment for the Arts grants (\$306,000 FF)
- **Archeological Research Center:** Avoided eliminating the archeological research center and 17.0 FTEs. General fund expenditure authority was replaced by \$308,782 of other fund expenditure authority to be funded from the one-half a percent increase in the gross receipts tax.
- **SD Ellsworth Development Authority:** The authority consists of 7 members created by the passage of HB 1301 for the purpose of protecting and promoting the economic impact of Ellsworth Air Force Base and associated industry, and to promote the health and safety of those living or working near the base. The Authority was provided \$175,000 of federal fund expenditure authority, \$200,000 of other fund expenditure authority, and 2.5 FTEs.
- **Science and Technology Authority:** Increased other fund expenditure authority by \$7,587,660 for contractual services and capital outlay to continue building the Sanford Laboratory at Homestake.
- **SD Housing Development Authority:** Increase of \$49,800 of other fund expenditure authority and 1.0 FTE for an additional person to help administer the South Dakota's portion of the Housing Recovery Act of 2008. This includes \$19 million in Neighborhood Redevelopment Funds for housing and \$96 million of bond volume cap funds for the refinancing of sub-prime loans.
- **Stimulus - Agriculture/Game Fish & Parks:** Fire dispatch and forestry field office, Custer State Park fuel management, and volunteer fire assistance (\$7,435,000 FF)
- **Stimulus - Agriculture:** Fund a four state initiative agreement to address the potential introduction of the emerald ash borer in South Dakota (\$421,000 FF)
- **Agriculture:** Increase of \$400,000 in general funds to the State Fair base budget. Funding in recent years was done through special appropriation bills.
- **Animal Industry Board:** Decrease of \$462,845 in federal fund expenditure authority due to federal budget reductions.
- **Stimulus - Game Fish & Parks:** Custer State Park fuel management project, Center Lake lagoon renovation, and campground enhancement at Hartford Beach State Park. (\$4,309,000 FF)

FY10 Major Budget Items, cont.

- **Game Fish & Parks:** Increase of \$298,072 in federal fund expenditure authority and \$2,853,656 in other fund expenditure authority for contracts with landowners for habitat development and the Sportsman Against Hunger program.
- **Stimulus - Transportation:** *Transit program (\$3,000,000 FF)*
- **Stimulus - Transportation:** *Transportation enhancements at the local level (\$3,240,000 FF)*
- **Stimulus - Transportation:** *Contract Construction Program (\$97,760,000 FF)*
- **Transportation-** Increase of \$3,924,814 in federal fund expenditure authority for pass through transit and metropolitan planning grants.
- **Transportation-** Decrease of \$10,000,000 in other fund expenditure authority due to the suspension of the 90/10 Swap Program.
- **Stimulus - Environment & Natural Resources:** *Clean Water SRF Program (\$19,239,100 FF)*
- **Stimulus - Environment & Natural Resources:** *Drinking Water SRF program (\$19,500,000 FF)*
- **Stimulus - Environment & Natural Resources:** *Diesel grants (\$1,750,000 FF)*
- **Stimulus - Environment & Natural Resources:** *Leaking Underground Storage Tank (LUST) Trust grants (\$1,500,000 FF)*

Justice & Public Safety

- **Stimulus - Highway Patrol:** *The Highway Patrol will receive \$1,319,060, or \$329,765 per year, of Byrne/JAG funding over the next four years for technology and equipments purchases.*
- **Highway Patrol** - Decrease in general fund expenditure authority of \$451,000 and an increase of \$1,433,768 in other fund expenditure authority. The other fund expenditure authority will be funded from increased driver licensing program fees and vehicle registration fees.
- **Emergency Management:** Decrease of \$1,000,000 in federal fund expenditure authority due to the flood map modernization program ending and lower capital outlay needs.
- **Homeland Security:** Decrease of \$1,500,000 in federal fund expenditure authority for homeland security grants to counties due to lower federal funding.
- **Corrections:** Decrease of \$800,000 from general funds due to a reduction in the inmate medical catastrophic fund agreement with the Department of Health.
- **Corrections:** Decrease of \$1,350,000 in other fund expenditure authority due to one-time funding for development of the Offender Management System in FY09.
- **Corrections:** Decrease of \$641,537 from general funds, \$17,500 in other fund expenditure authority, \$29,770 in federal fund expenditure authority, and 13.0FTEs due to the closure of the Redfield Minimum Unit.
- **Corrections:** Increase of \$638,633 from general funds and 9.0 FTEs to the base budget for the Intensive Methamphetamine Program (IMT). Funding for this program in recent years has been done through special appropriation bills.
- **Corrections:** Increase of \$912,365 from general funds for non-Medicaid eligible juvenile placement services.
- **Stimulus - Attorney General:** *The Legal Services Division will receive \$1,978,590 of Byrne/JAG funding over the next four years to be used for equipment, supplies, weapons replacement, and to provide backup records. Of this amount \$701,055 was budgeted for FY 2010.*
- **Attorney General:** Increased other fund expenditure authority by \$624,206 to provide additional funding for the 24/7 sobriety program.
- **24/7 Program:** Special appropriation to the Attorney General's 24/7 sobriety fund for \$370,553 in other funds with an emergency clause to be effective in FY09.
- **Stimulus - Military & Veterans Affairs - Funding for projects at the Huron Airport, Range Road Armory and the Brookings Armory (\$439,905 FF)**
- **Military & Veterans Affairs:** Increase of \$320,000 in federal fund expenditure authority for an additional fourth program that was added to the STARBASE youth program and additional funding to the other three programs.
- **Unified Judicial System:** Increase of \$426,019 in general fund expenditure authority personal services and 5.0 FTEs for two circuit court judges in Pennington and Minnehaha Counties, two court reporters in Pennington and Minnehaha Counties, and a law clerk in the seventh judicial circuit.
- **Fourth Circuit Drug Court:** Continued the program by funding it in the general appropriations act with \$247,358 of general funds, \$10,000 of other funds, and 3.0 FTEs.
- **Unified Judicial System:** Increase of \$1,020,515 in other fund expenditure authority to begin an upgrade of the UJS Case Management Systems.
