

Interim Study Survey

LRC will then compile the survey results and distribute them to the Executive Board for consideration at its April 18th meeting.

Study A

Title of Requested Study: A study of the treatment of domestic and agricultural animals and how to properly regulate the treatment of each classification.

Scope of Requested Study: Examine current animal cruelty and animal treatment laws in South Dakota, how the laws apply to domestic animals versus agricultural animals, and what changes may be necessary to tailor the laws to fit each group.

Study B

Title of Requested Study: Repealing the sales tax on food.

Scope of Requested Study: To determine the practicality of repealing the sales tax on food as a way to assist low to moderate income families.

Study C

Title of Requested Study: Truth and Reconciliation Commission. (This was supported in the State Tribal Relations Committee and in 2015 a letter that was sent to the Governor from the Committee requesting the establishment of this Commission.)

Scope of Requested Study: I believe race is still an issue that needs to be addressed by the state. The courts have just ruled again against DSS regarding ICWA in favor of 2 tribes in the state, and in another case, a man from Philip poured beer on Native students at a school function in Rapid City. There are some questions regarding ethics with money and contracts that serve our youth such as Gear Up, as well as the lack of investment or assistance financially in our reservation communities despite millions of EBS dollars and others. Our courts, jails, and penal system are disproportionately full of Natives.

Study D

Title of Requested Study: Civil forfeiture in South Dakota: A study of the process, the volume of assets seized, how the seized assets are managed and disposed of, the reporting process, possible abuses, and how South Dakota's process compares to other states.

Scope of Requested Study:

- Breakdown seized assets by crime, by type of asset, and by volume.

- Cost to seize assets.
- How often do seizure efforts fail?
- What process is used to dispose of assets?
- How are funds held? Checks and balances?
- What reporting is done?
- Due process and the burden of proof in forfeitures.

Study E

Title of Requested Study: Fencing laws and penalties.

Scope of Requested Study: As there gets to be more land owners that either don't have cattle or are only interested in hunting, they feel that fencing is not their responsibility. We need to see if we can put more teeth into the statutes that we have. Possibly look at the fencing of streams as well.

Study F

Title of Requested Study: Study a revision to the process of developing the general appropriations act.

Scope of Requested Study: The study would look at the possibility of getting all legislators involved in the budget process. The study should consider the possibility of each legislator being appointed to a committee to develop the budget of the state agencies assigned to the committee. Each committee would meet for up to eight days in October and November to help develop a proposed budget for each agency assigned to the committee. Each committee would consist of at least one member of the appropriations committee. Each committee would use a zero-based budgeting process. Each committee would make their recommendations to the next legislative session.

- How have the issues surrounding this industry and its constituents changed in recent years?

- What are the pro and con results from these regulations? Who benefits? How are these results measured/quantified? What are the trends?
- How can more "free enterprise" be introduced into our management of care facilities?
- What are the forecasted changes for the industry in South Dakota and its constituents?
- How can the industry best respond to demographic and geographic changes in the state and what role should the state play in these changes for the benefit of all concerned?

Study K

- Actual costs versus cost report data - What is included in cost reports - cost report years used for calculation.
- Projection of provider needs 5/10/20 years.
- Costs unaccounted for in reports.
- Other payment methodologies used in other states - Pros/Cons.
- Recommendations for any change.
- Funding sources for any changes for recommended increases.
- Sustainability and future growth.

Legislator	Comments
Greenfield (Lana)	As we have a meth problem in our area, I am interested in this study. We started community meetings and need to know how to proceed from here. Thank you for your consideration.
Haugaard	I would be glad to serve on any of these committees. The others I didn't rank in the top 5 are also worthy of consideration.
Hunhoff (Jean)	In the last two years we have addressed roads and education. As we go forward we are facing an increasing older population that is going to need to be addressed for access and appropriate level of care and services to serve both the rural and urban areas. The updated Long Term Care Study should be the guide to what those needs are and strategies to ensure South Dakotans have placement either in their homes or facilities that allow for transition to the levels needed. Bottom line is that we have not drilled down into the types and costs for those levels of care and how we are going to pay for them. Other than births on the reservations, this is the fastest growing population in South Dakota. We need to have a plan in place and a viable methodology to support this expenditure. Solutions need to include further partnerships with the public and private providers in the delivery of Medicaid services in South Dakota. Thank you. Representative Jean Hunhoff
Rozum	So many suggestions do not seem to warrant a summer study or may be part of an existing task force.
Schoenbeck	A fair number of those options are a terrible waste of legislator time and the taxpayers resources.
Soholt	Study J: Should look at plan for aging in SD that includes resources for in-home care "aging in place" - the full continuum should be assessed along with funding for each to identify gaps and establish plan for decade of development. Study H: Also include demographic trends for townships and what the goals would be for future development (if should be continued with that populace), and what options there are for growth/consolidation to be most efficient with taxpayer dollars.
Soli	It is long past time to give serious and thoughtful consideration to positive approaches to providing healing and hope for Native Americans and the issues affecting our whole state related to these first residents of South Dakota. Let's work on C.
