## Study A

**Title of Requested Study:** Native American Healthcare within the Tribes

**Scope of Requested Study:**

- IN-MED a North Dakota course for graduating seniors taking a 6-week course on Native medicine (natural and/or herbal).

**Title of Requested Study:** Preparing for a Comprehensive Study of South Dakota's Tax Structure

**Scope of Requested Study:** With this proposal, a working group this summer would lay the groundwork for an extensive interim study of South Dakota's tax system, to be conducted one or two years from now. The lead time is needed to arrange for written analyses of various aspects of the state tax structure, schedule out-of-state tax experts to testify, and set up public meetings around the state. The initial working group might include, for example, four legislators from Taxation and/or Appropriations committees, one representative each from BFM and Department of Revenue, two university faculty members, and two representatives from the public and/or business community. The working group might use the Nebraska Tax Modernization Committee Report (2013) as a model.
