The Governor of South Dakota, along with the South Dakota Legislature, the South Dakota Veterans Council and the South Dakota Department of Veterans Affairs have worked together to secure authorization for the design, construction, and equipping of a State Veterans Cemetery in Minnehaha County. Senate Bill 91 also authorized the State Veterans Council to establish a State Veterans Cemetery Endowment Fund to help offset costs associated with the maintenance and upkeep of the State Veterans Cemetery.

The South Dakota Veterans Council and its partners have agreed to raise \$3 Million to provide financial support to the State of South Dakota for the operation of the State Veterans Cemetery in Minnehaha County.

The South Dakota Community Foundation has partnered with the South Dakota Veterans Council to establish the "South Dakota State Veterans Cemetery Fund."

Your donation will be added to the South Dakota State Veterans Cemetery Fund. These funds will be invested in perpetuity, and earnings of interest and dividends will be available annually to support the State Veterans Cemetery.

What gets done with the Endowment Fund?

The gifts given live on as the Fund's principal. The interest and dividends fund the maintenance and upkeep of the State Veterans Cemetery.

The annual grant making distribution will be no more than 5% of the average fair market value of total endowment.
