WHEREAS, Milo Smith of Pierre has served as an Assistant Sergeant at Arms since 1995 in the Senate and the House of Representatives, a position that has provided him with a ring-side seat to many important moments in South Dakota history and earned him the friendship of several generations of South Dakota legislators; and

WHEREAS, Milo Smith, a native of Pierre, South Dakota, attended Pierre High School and South Dakota State University in Brookings. He served in the South Dakota Army National Guard, including active duty service in Alaska during the Korean War; and

WHEREAS, Milo Smith has been an enthusiastic participant and sponsor of athletics in the Pierre community, particularly baseball. He played Legion and men's amateur baseball in Pierre and was a member of the semipro Pierre Cowboys Basin League team. He also sponsored and managed



amateur baseball teams in Pierre for many years during the 1970s and 1980s; and
