SENATE BILL NO. 177

Introduced by: The Committee on Health and Human Services at the request of the Office of the Governor

1 FOR AN ACT ENTITLED, An Act to establish a program to assist rural communities to recruit
2 certain health care professionals and to repeal certain provisions regarding the physician and
3 the dentist tuition reimbursement programs.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 Section 1. The Department of Health may establish a program to assist rural communities
6 in recruiting physicians, dentists, physician assistants, nurse practitioners, and nurse midwives.

7 Section 2. A rural community eligible to participate in the recruitment assistance program
8 is any community in this state which:

- 9 (1) Has a population of ten thousand persons or less;
- 10 (2) Agrees to provide its portion of the incentive payment pursuant to the provisions of
11 this Act; and
- 12 (3) Is determined to be eligible by the Department of Health.

13 Before making a determination of eligibility, the Department of Health shall conduct a
14 community assessment designed to evaluate the community's need for eligible providers and its
15 ability to sustain and support the additional providers. The department shall maintain a list of



1 communities which have been assessed and which are eligible for participation in the
2 recruitment assistance program established by this Act. The department may revise any
3 community assessment or conduct a new assessment as necessary to reflect any change in
4 conditions within a community.

5 Section 3. A physician is eligible to participate in the recruitment assistance program
6 established pursuant to this Act if the physician is licensed to practice medicine pursuant to
7 chapter 36-4 and has completed an accredited residency program in family practice, pediatrics,
8 internal medicine, or obstetrics/gynecology, and if the physician agrees to practice in an eligible
9 rural community for a minimum period of three years. However, no more than fifteen physicians
10 may participate in the program at any specified time. Preference shall be given to physicians
11 who have graduated from the University of South Dakota School of Medicine and completed
12 an accredited residency program located in South Dakota.

13 A dentist is eligible to participate in the recruitment assistance program established pursuant
14 to this Act if the dentist is licensed to practice dentistry pursuant to chapter 36-6A and agrees
15 to practice general dentistry in an eligible rural community for a minimum period of three years.
16 However, no more than five dentists may participate in the program at any specified time.

17 A physician assistant, nurse practitioner, or nurse midwife is eligible to participate in the
18 recruitment assistance program established pursuant to this Act if the physician assistant, nurse
19 practitioner, or nurse midwife is licensed to practice pursuant to chapter 36-4A or chapter
20 36-9A, respectively, and has completed an accredited physician assistant, nurse practitioner, or
21 nurse midwife program and if the person agrees to practice as a primary care physician assistant,
22 family nurse practitioner, or nurse midwife in an eligible rural community for a minimum period
23 of three years. However, no more than a cumulative total of fifteen physician assistants, nurse
24 practitioners, or nurse midwives may participate in the program at any specified time.

1 Section 4. A physician or dentist who fulfills the requirements of the recruitment assistance
2 program established pursuant to this Act, is entitled to receive an incentive payment in an
3 amount equal to twice the University of South Dakota School of Medicine resident tuition for
4 the four most recently completed academic years.

5 A physician assistant, nurse practitioner, or nurse midwife who fulfills the requirements of
6 the recruitment assistance program established pursuant to this Act, is entitled to receive an
7 incentive payment in an amount equal to twice the University of South Dakota resident tuition
8 for physician assistant studies for the three most recently completed academic years.

9 Section 5. Any agreement for the payment of recruitment assistance pursuant to this Act
10 shall obligate the rural community to be served by a physician, dentist, physician assistant, nurse
11 practitioner, or nurse midwife to provide a portion of the total amount of the incentive payment,
12 based on the following criteria: communities of two thousand five hundred persons or less shall
13 provide twenty-five percent of incentive payments; communities of more than two thousand five
14 hundred persons and less than five thousand persons shall provide fifty percent of incentive
15 payments; and all remaining eligible communities shall provide seventy-five percent of
16 incentive payments. When the rural community certifies to the secretary of health that it has paid
17 the full amount for which it is obligated, the secretary of the Department of Health shall pay to
18 the physician, dentist, physician assistant, nurse practitioner, or nurse midwife the remaining
19 balance of the total incentive payment amount. The secretary shall pay the required amount out
20 of funds appropriated by the Legislature for such purpose. The incentive payment shall be paid
21 upon completion of the required three-year practice period by the physician, dentist, physician
22 assistant, nurse practitioner, or nurse midwife. However, a community may pay its portion of
23 the incentive payment at any time during the three-year period.

24 Section 6. Any municipality or county may appropriate funds for the purpose of carrying out

1 the provisions of this Act.

2 Section 7. No recruitment assistance agreement entered into pursuant to the provisions of
3 this Act is effective until it is filed with and approved by the secretary of health. The secretary
4 may prescribe the format of the agreements and procedures for approval.

5 Section 8. No person may participate in the program established pursuant to the provisions
6 of this Act if the person has previously participated in such program, or any other state or federal
7 scholarship, loan repayment, or tuition reimbursement program which obligates the person to
8 provide medical services within an underserved area.

9 Section 9. Any person participating in the program established pursuant to the provisions
10 of this Act shall agree to be a participating South Dakota medical assistance provider and to
11 serve any individual eligible under chapter 28-6 and may not refuse treatment to any such
12 individual while participating in the program.
