HCR 1005 (HJ p. 273) Urging Congress to clearly delegate responsibility for the regulation of hydraulic fracturing to the states.

SB 137 revise certain provisions concerning the application for absentee voting.
SB 107 revise certain provisions regarding personalized motor vehicle license plates.
HB 1077 authorize municipalities to establish incidental accounts.
HB 1094 require the filing of certain documents relating to the vacation, location, or changing of highways with the register of deeds.

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

SB 71 (Deferred from 15th LD) modify the requirements relating to the publication of the administrative rules.

SB 127* revise certain provisions regarding educational data reporting.

SB 25* provide for the creation of a new state accountability system and a new financial accountability rating system for public elementary and secondary schools.

- SB 46* authorize the Board of Regents to purchase an airport structure for use by South Dakota State University and to make an appropriation therefor.
- SB 141* revise the legal definition of the term, domestic abuse.
- SB 156* establish strangulation as one element of the crime of aggravated assault.
- SB 99* ~~provide for a temporary suspension of certain licenses relating to alcoholic beverages under emergency conditions.~~
Prohibit certain licensees or employees of a licensed establishment who have been charged with certain felony offenses from entering the licensed premises and to provide a penalty therefor.
- SB 142 impose the sales tax on the gross receipts derived from renting mini-storage units, self-storage units, or storage space and the use tax on the use of mini-storage units, self-storage units, or storage space.
- SB 162 create certified technology parks and to provide certain financing mechanisms and bonding authority to enhance knowledge and tech-based economic development and to repeal certain provisions concerning certified technology parks.

- HB 1069 (Deferred from 15th LD) increase the amount of income and principal of a perpetual fund used to maintain a cemetery.
