1 FOR AN ACT ENTITLED, An Act to provide for bonding authorization for the postsecondary
2 technical institutes and to authorize bonds for lease purchase agreements with Western
3 Dakota Technical Institute and Southeast Technical Institute.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 Section 1. That chapter 1-16A be amended by adding thereto a NEW SECTION to read as
6 follows:

7 Beginning July 1, 2013, any bonds, notes or other obligations of the authority which are
8 payable out of receipts, rentals, and other payments made pursuant to lease purchase agreements
9 with the Western Dakota Technical Institute, the Southeast Technical Institute, the Lake Area
10 Technical Institute, the Mitchell Technical Institute, or the South Dakota Board of Education
11 under the authority of chapter 13-39 may only be issued if the Board of Education determines,
12 by the adoption of a resolution, that the estimated receipts, rentals, and other payments,
13 including appropriations by the Legislature, student fee payments, or other balances or revenues



1 pledged under the applicable bond indenture or similar agreement will not be less than one
2 hundred three percent of the projected scheduled payments of principal and interest on all
3 outstanding bonds which, for purposes of that determination shall include the proposed bonds
4 to be issued and shall exclude any bonds to be refunded. In issuing additional bonds, the
5 authority may conclusively rely upon the determination of the board.

6 Section 2. That chapter 1-16A be amended by adding thereto a NEW SECTION to read as
7 follows:

8 The South Dakota Board of Education shall promulgate rules pursuant to chapter 1-26
9 establishing a methodology for forecasting anticipated contributions from student tuition and
10 fees and additional state appropriations available pursuant to a lease purchase agreement to meet
11 the projected scheduled payments of principal and interest on all outstanding bonds and other
12 benchmarks.

13 Section 3. That chapter 1-16A be amended by adding thereto a NEW SECTION to read as
14 follows:

15 Beginning on July 1, 2013, the issuance of any additional bonds, notes, or other obligations
16 shall be approved by the Legislature before issuance. This requirement, however, does not apply
17 to the issuance of bonds for the purposes of refinancing or refunding existing bonds, notes, or
18 other obligations.

19 Section 4. The issuance by the Health and Educational Facilities Authority of additional
20 bonds, notes, or other obligations in a principal amount not to exceed eighteen million five
21 hundred thousand dollars for a lease purchase agreement with the Western Dakota Technical
22 Institute to finance the acquisition, construction, and other costs associated with technical lab
23 space and classrooms for various programs, including diesel technician and technology,
24 agriculture science, construction technology, fire science, paramedic and emergency medical

1 technicians, and to remodel the South Mickelson building is hereby authorized and approved.

2 Section 5. The issuance by the Health and Educational Facilities Authority of additional
3 bonds, notes, or other obligations in a principal amount not to exceed twenty million dollars for
4 a lease purchase agreement with the Southeast Technical Institute to finance the acquisition,
5 construction, and other costs associated with a transportation technology center to house various
6 technical programs, including diesel, auto, and auto body collision programs and other facility
7 improvements necessary for other programs is hereby authorized and approved.

8 Section 6. Beginning in fiscal year 2015, payments made pursuant to lease purchase
9 agreements with the Western Dakota Technical Institute, the Southeast Technical Institute, the
10 Lake Area Technical Institute, the Mitchell Technical Institute, or the South Dakota Board of
11 Education under the authority of chapter 13-39 shall be paid in part from an appropriation to be
12 made by the Legislature in an amount that is equal to or greater than fifty percent of the
13 technical institute facility fee that is administered by the Department of Education.

14 Section 7. That § 1-16A-77 be repealed.

15 ~~1-16A-77. The aggregate outstanding principal amount of bonds, notes, or other obligations~~
16 ~~of the authority which are payable out of receipts, rentals, and other payments made pursuant~~
17 ~~to lease purchase agreements with an LEA or the South Dakota Board of Education under the~~
18 ~~authority of chapter 13-39, may not exceed one hundred five million dollars for obligations~~
