23 Section 9. That chapter 30 of the 2012 Session Laws be amended by adding a NEW  
24 SECTION to read as follows:

1 The state treasurer shall transfer to the boxing commission fund, ninety-five thousand  
2 dollars (\$95,000) from the state general fund.

3 Section 10. That section 6 of chapter 41 of the 2012 Session Laws be amended to read as  
4 follows:

5 Section 6. ~~The funds in section 7 of this Act which are unspent at the end of fiscal year 2012~~  
6 ~~may be carried over to the next fiscal year~~ provisions of § 4-8-19 do not apply to the funds in  
7 section 7 of this Act.

8 Section 11. That chapter 30 of the 2012 Session Laws be amended by adding thereto a NEW  
9 SECTION to read as follows:

10 Section 38. The state treasurer shall transfer to the employer's investment in South Dakota's  
11 future fund two million dollars (\$2,000,000), from the state general fund.

12 Section 12. Funds appropriated in this Act which are unspent at the end of fiscal year 2013  
13 may be carried over to fiscal year 2014.

14 Section 13. The sum of nine hundred eighty-three thousand six hundred forty-nine dollars  
15 (\$983,649) in the general fund on June 30, 2013, shall be obligated and committed for the  
16 purposes of future appropriations in FY2014. The provisions of §§ 4-7-32 and 4-7-39 do not  
17 apply to these funds.

18 Section 14. Notwithstanding section 145 of HB 1060 as previously enacted by the Eighty-  
19 Eighth Legislature, up to twenty million dollars (\$20,000,000) in general funds appropriated in  
20 subsection (3) of section 8 of chapter 30 of the 2012 Session Laws which are unspent at the end  
21 of fiscal year 2013 may be carried over to fiscal year 2014 for medical and adult services. Any  
22 additional unspent general funds shall revert in accordance with chapter 4-8. Federal and other  
23 funds appropriated in subsection (3) of section 8 of chapter 30 of the 2012 Session Laws which  
24 are unspent at the end of fiscal year 2013 may be carried over to fiscal year 2014 for medical

1 and adult services.

2 Section 15. This Act is effective June 26, 2013.
