- [SB 13](#) revise certain provisions relating to the administration of mineral rights on and under research parks.
- [SB 32](#) revise the provisions under which the Bureau of Administration may enter into contracts for insurance and reinsurance.
- [SB 12](#) update citations and revise certain provisions regarding permits for energy facilities.
- [SB 67](#)* revise the requirements for health maintenance organizations.
- [SB 85](#)* revise certain provisions regarding the production incentive payment available to ethanol producers.

- [SB 52](#) authorize one cent credit denominations for video lottery machines, to authorize the award of one thousand dollars on a video lottery machine, and to make form and style changes to certain provisions regarding the lottery.
- [SB 23](#)* (Deferred from the 26th LD) revise certain provisions pertaining to the Certification Board for Alcohol and Drug Professionals and to increase certain fees.

- [SB 41*](#) (Deferred from the 26th LD) revise certain provisions regarding the requirements for school bus inspection and to authorize the Highway Patrol to approve school bus inspectors.
- [SB 45](#) (Deferred from the 26th LD) permit certain persons to renew an operator's license, a motorcycle operator's license, or nondriver identification card without appearing in person at a driver license exam site.
- [SB 72*](#) (Deferred from the 26th LD) revise certain provisions concerning inspections of food service establishments by the Department of Health.
- [SB 18*](#) (Deferred from the 26th LD) authorize the Department of Agriculture to construct a 4-H exhibit hall in Huron and to make an appropriation therefor.
- [SB 19*](#) (Deferred from the 26th LD) authorize the Department of Agriculture to construct a housing unit in Huron, to make an appropriation therefor, and to declare an emergency.
- [SB 27](#) (Deferred from the 26th LD) revise previous session laws related to the design, construction, and equipping of a veterans home near Hot Springs, to make an appropriation therefor, and to declare an emergency.
- [SB 78*](#) (Deferred from the 26th LD) revise certain provisions relating to medical requirements for intrastate drivers transporting passengers and to update certain references to federal statutes.
- [SB 86](#) (Deferred from the 26th LD) increase the minimum salary payable to county officials, state's attorneys, and sheriffs.
- [SB 156*](#) (Deferred from the 26th LD) authorize township boards to increase the front foot assessment for road maintenance, repairs, and improvements and to revise certain provisions concerning road districts established by townships.
- [SB 68](#) (Deferred from the 26th LD) revise the controlled substance schedule and to declare an emergency.
- [SB 88](#) (Deferred from the 26th LD) authorize the county to deny bids on county sales of tax deed properties if the bidder is not current on property taxes due.
- [SB 145*](#) (Deferred from the 26th LD) revise certain provisions concerning the content of annual property tax bill.
- [SB 96*](#) (Deferred from the 26th LD) exempt certain school districts from the requirement to reorganize due to low enrollment.
- [SB 22](#) (Deferred from the 26th LD) make an appropriation for the construction and renovation of certain office buildings in Rapid City for the Department of Agriculture and to declare an emergency.
- [SB 29](#) (Deferred from the 26th LD) authorize the Department of the Military to purchase land for use by the South Dakota Army National Guard, to make an appropriation therefor, and to declare an emergency.
- [SB 30](#) (Deferred from the 26th LD) authorize the Department of the Military to construct a motor vehicle storage building in Sioux Falls, to make an appropriation therefor, and to declare an emergency.
- [SB 239](#) (Deferred from the 26th LD) repeal the state's membership in the multistate tax commission.
- [SB 69*](#) (Deferred from the 26th LD) revise certain provisions of the health professionals diversion program.
- [SB 103](#) (Deferred from the 26th LD) remove the required waiting period before cremated remains may be released to be scattered.

- [SB 118](#) (Deferred from the 26th LD) provide for the issuance of a resident medical license and to repeal certain resident training permits issued by the Board of Medical and Osteopathic Examiners.
- [SB 10](#) (Deferred from the 26th LD) authorize the Board of Regents to contract for the construction of swine teaching and research facilities at South Dakota State University and to make an appropriation therefor.
- [SB 11](#) (Deferred from the 26th LD) authorize the Board of Regents to contract for the construction of an indoor practice and human performance facility on the campus of South Dakota State University and to make an appropriation therefor.
- [SB 189](#) (Deferred from the 26th LD) make appropriations from the water and environment fund, the water pollution control revolving fund subfund, and the drinking water revolving fund subfund for various water and environmental purposes and to declare an emergency.
- [SB 190*](#) (Deferred from the 26th LD) make an appropriation to fund tax refunds for elderly persons and persons with a disability, to revise the income eligibility requirements for property and sales tax refunds, and to declare an emergency.
- [SB 151*](#) clarify the maintenance responsibilities on unimproved section lines.
- [SB 158](#) provide for the funding of educational programs for children in residential treatment centers, intensive residential treatment centers, or licensed group care centers.
- [SB 3*](#) require the reporting of the outcomes of certain licensure and certification examinations.
- [SB 4](#) require the Department of Labor and Regulation to determine certain job placement outcomes for graduates of all public postsecondary education institutions in the state.
- [SB 33](#) authorize the use of an online reverse auction for the procurement of certain goods and services by governmental agencies.
- [SB 35](#) allow the prosecution to appeal from certain judgments of acquittal.
- [SB 36](#) protect the identity of the person or entity supplying the intravenous injection substance for executions and to increase the penalty for a violation of those provisions.
