SECOND READING OF CONSENT CALENDAR ITEMS

- [SB 126](#) revise the provisions that authorize townships to combine the offices of the clerk and the treasurer.
- [SB 118](#) provide for the issuance of a resident medical license and to repeal certain resident training permits issued by the Board of Medical and Osteopathic Examiners.
- [SB 204](#) revise certain provisions regarding the deposit and expenditure of tobacco settlement revenues and bond proceeds.
- [SB 120](#) revise provisions related to consent to sexual activity.
- [HB 1026](#) comply with certain Internal Revenue Code requirements relating to maximum annual benefits paid to members of the South Dakota Retirement System and to provide for the update of references to the Internal Revenue Code.
