HJR 1002      (Deferred from 19<sup>th</sup> LD) making a formal application to the President of the United States, that the President grant a presidential pardon to Peter L. Larson.  
HB 1105\*      (Deferred from 20<sup>th</sup> LD) provide for an affidavit creating a rebuttable presumption that a person is not an employee for purposes of workers' compensation and to provide a penalty therefor.

- HB 1194\* (Deferred from 21<sup>st</sup> LD) set a minimum size for a sign about zoning changes or conditional use permits.
- HB 1030\* (Deferred from 21<sup>st</sup> LD) provide certain restrictions regarding the passing of a bicycle.
- HJR 1003 (Deferred from 21<sup>st</sup> LD) Proposing and submitting to the electors at the next general election an amendment to Article XIV of the Constitution of the State of South Dakota, relating to the authority of the Board of Regents.
- HB 1161 (Deferred from 21<sup>st</sup> LD) limit certain rule making authority of the South Dakota High School Activities Association.
- HB 1118\* provide for oversight of postsecondary technical institutes.
- HB 1215\* provide for an optional enhanced permit to carry a concealed pistol.
- HB 1067\* establish maximum reproduction costs for medical records.
- HB 1082\* allow a law enforcement officer to issue a citation without a notary.
- HB 1229 revise provisions related to the release of medical waste.
- HB 1147 increase the amounts of the annual awards given to recipients of the South Dakota opportunity scholarship.
- HB 1186 revise an appropriation made to the Science and Technology Authority.
- HJR 1005 Designating Oglala Lakota County as the new name of Shannon County.

- SB 77\* (Removed from Consent Calendar; Deferred from 21<sup>st</sup> LD) allow nursing mothers to breastfeed in certain locations.
- SB 16 (Removed from Consent Calendar; Deferred from 21<sup>st</sup> LD) revise certain provisions safeguarding law enforcement radio communications.
- SB 40 (Removed from Consent Calendar; Deferred from 21<sup>st</sup> LD) revise certain provisions regarding the federal motor carrier regulations.
- SB 43\* (Deferred from 21<sup>st</sup> LD) revise certain provisions regarding lease purchase agreement payments and to ratify certain lease purchase agreements with the Health and Educational Facilities Authority.
- SB 75\* (Deferred from 21<sup>st</sup> LD) revise the effective period of the travel permit for certain livestock used for rodeo purposes and to declare an emergency.
- SB 76 (Deferred from 21<sup>st</sup> LD) extend the length of time a local livestock ownership inspection certificate is valid for transportation.
- SB 93 impose a gross receipts tax on the rental of certain motorcycles in lieu of the excise tax on motor vehicles.
- SB 45\* revise certain provisions relating to the sale of unpasteurized raw milk.
- SB 41 revise certain provisions pertaining to commercial driver licensing.
- SB 94 establish a license fee for electric-powered motorcycles.
