SB 142 (Deferred from 24th LD) enhance South Dakota.
SB 192 (Deferred from 24th LD) permit the sergeant-at-arms to carry concealed firearms in the state capitol building under certain conditions.
SB 91* (Deferred from 24th LD) make an appropriation to support the South Dakota need-based grant program.
SB 92* (Deferred from 24th LD) make an appropriation to support the South Dakota critical teaching needs scholarship program.
SB 3* (Deferred from 24th LD) provide for mediation of certain drainage disputes.

- HB 1081* (Deferred from 24th LD) repeal certain provisions regarding county officials and the board of county commissioners.
HB 1080* (Deferred from 24th LD) authorize the use of investigational treatments for patients under certain conditions and to restrict certain causes of action arising from investigational treatment.
HB 1089 (Deferred from 24th LD) ban the practice of female genital mutilation in the state, to provide a penalty therefor, and to declare an emergency.
HB 1130* (Deferred from 24th LD) prohibit an abortion provider from accepting payment for an abortion prior to the end of the required informed consent period.
HB 1058* (Deferred from 24th LD) revise certain provisions regarding contagious disease control quarantine measures.
HB 1059* (Deferred from 24th LD) allow authorized entities to access immunization information in certain circumstances.
HB 1043* (Deferred from 24th LD) repeal certain outdated and obsolete provisions regarding the Department of Education.
HB 1013* (Deferred from 24th LD) revise certain provisions related to social work licensure.
