SB 101* establish certain provisions regarding cancer treatment medication coverage by insurance companies.

SB 53 revise certain provisions regarding the state aid to general education formula and to revise the property tax levies for the general fund of school districts.

- SB 54 revise certain provisions regarding the state aid to special education formula and to revise the property tax levies for special education.
- SB 139 authorize the increase in the number of video lottery machines that may be placed in a licensed establishment under certain conditions.
- SB 140 accommodate legislation relating to education in South Dakota.
- SB 159 (Reconsideration, Deferred 25th LD) exempt certain amateur sports coaches from sales and use tax.
- SB 189* provide a tax credit to insurance companies that contribute to an organization providing educational scholarships to certain students and instructional supply grants to certain teachers and parents.
- SB 141 (Deferred from 25th LD) accommodate legislation on medical services.
- SB 142 (Deferred from 25th LD) enhance South Dakota.
- SB 192 (Deferred from 25th LD) permit the sergeant-at-arms to carry concealed firearms in the state capitol building under certain conditions.
- SB 91* (Deferred from 25th LD) make an appropriation to support the South Dakota need-based grant program.
- SB 92* (Deferred from 25th LD) make an appropriation to support the South Dakota critical teaching needs scholarship program.
- SB 3* (Deferred from 25th LD) provide for mediation of certain drainage disputes.

- HB 1027* revise certain provisions regarding the regulation of certain money lending activities.
- HB 1081* (Deferred from 25th LD) repeal certain provisions regarding county officials and the board of county commissioners.
- HB 1080* (Deferred from 25th LD) (Amended HJ 344) authorize the use of investigational treatments for patients under certain conditions and to restrict certain causes of action arising from investigational treatment.
- HB 1089 (Deferred from 25th LD) ban the practice of female genital mutilation in the state, to provide a penalty therefor, and to declare an emergency.
- HB 1130* (Deferred from 25th LD) prohibit an abortion provider from accepting payment for an abortion prior to the end of the required informed consent period.
- HB 1058* (Deferred from 25th LD) (Amended HJ 185, 186) revise certain provisions regarding contagious disease control quarantine measures.
- HB 1059* (Deferred from 25th LD) (Amended HJ 210) allow authorized entities to access immunization information in certain circumstances.
- HB 1043* (Deferred from 25th LD) repeal certain outdated and obsolete provisions regarding the Department of Education.
- HB 1013* (Deferred from 25th LD) revise certain provisions related to social work licensure.
