Amended HJ 22nd LD: HB 1047, HB 1161, HB 1132, HB 1133, HB 1167, HB 1243

HB 1238 revise the powers and duties of the Executive Board of the Legislative Research Council.

SB 8* revise certain provisions regarding background investigations for prospective employees of the postsecondary technical institutes and to transfer certain funds regarding postsecondary technical credentialing.

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

HB 1182 (JR 5-17 with pending amendment; HJ 364) increase the state sales tax, the state use tax, the excise tax on farm machinery, and amusement device tax for the purpose of increasing education funding and reducing property taxes, and to declare an emergency.

HB 1204* ~~provide a sales tax exemption for certain nonprofit corporations created for the purpose of fire protection.~~
provide a sales and use tax exemption for certain nonprofit corporations created for the purpose of fire protection.

HB 1177* revise certain provisions concerning tax incentives for certain energy facilities.

- HB 1206* authorize the use of handguns in the hunting of game birds.
HB 1024 make an appropriation for the maintenance and repair of state owned dams and to declare an emergency.
HB 1209 require any public body of the state to accept as valid all information on a person's birth certificate.
HB 1244 revise provisions related to the sex offender registry

- SB 2* (Deferred from 22nd LD) revise the distribution of the revenue from the alcoholic beverage fund.
SB 34 (Deferred from 22nd LD) revise certain provisions regarding the chemical testing of commercial drivers.
SB 120* (Deferred from 22nd LD) make an appropriation to reimburse certain family physicians, dentists, physician assistants, and nurse practitioners who have complied with the requirements of the recruitment assistance program and to declare an emergency.
SB 63* require the development of school safety plans and to require the conduct of school safety drills in accredited schools.
