- SB 63* (Deferred from 29th LD) require the development of school safety plans and to require the conduct of school safety drills in accredited schools.
- SB 58* (Deferred from 29th LD) revise certain restrictions for the use of night-vision equipment for hunting under certain conditions.
- SB 81* (Deferred from 29th LD) create the paraprofessional tuition assistance scholarship program.
- SB 55 (Deferred from 29th LD) revise certain provisions relating to the HOPE probation program.
- SB 79* (Deferred from 29th LD) expand the list of professionals authorized to perform certain examinations required for a plea of guilty but mentally ill.
- SB 97* (Deferred from 29th LD) ~~provide for the automatic removal of all Class 2 misdemeanor convictions from background check records after ten years under certain conditions.~~
provide for the automatic removal of all petty offenses, municipal ordinance violations, and Class 2 misdemeanor charges or convictions from background check records after ten years under certain conditions.

- SB 50* (Deferred from 29th LD) revise the allocation of certain fees collected by the Department of Corrections.

revise provisions related to the legislative intern program.

- SB 3 (Deferred from 29th LD) revise the income criteria for determining if property is classified as agricultural land for property tax purposes.
- SB 80* (Deferred from 29th LD) limit certain liability for hosts of fishing tournaments.
- SB 2* (Deferred from 29th LD) revise the distribution of the revenue from the alcoholic beverage fund.
- SB 102 allow certain alcoholic beverage licenses and special event alcoholic beverage licenses to be issued on certain lands and facilities located on state educational institution campuses.
- SB 69* require accredited schools to accept transfer credits for courses taken by students from other accredited schools during the summer and to declare an emergency.
- SB 129* establish certain suicide awareness and prevention training requirements for certain school employees based on the Jason Flatt Act.
- SB 31 revise certain provisions regarding the sentencing and supervision of prison inmates and parolees with suspended sentences.
