- SB 91* revise certain provisions concerning the information on the forms provided to persons who sign initiated constitutional amendments, referred laws, or initiated measures.
- HB 1066* revise certain provisions regarding the public notice for a meeting of a public body.
- HB 1100 set a minimum size for a sign about zoning changes or conditional use permits.
- HB 1103 revise certain provisions regarding the qualification process for municipal office.
- HB 1039* (Amended HJ 171) revise various trust and trust company provisions and to establish and regulate South Dakota special spousal trusts.
- HB 1027* revise certain provisions regarding licensure of massage therapists.

SB 108 (Deferred from 17th LD) require notice if certain immunizations contain more than trace amounts of mercury.

SB 5* (Deferred from 17th LD) revise the procedure to initiate a school district boundary change.

HB 1098 revise certain provisions regarding the exemption of motor vehicles from the motor vehicle excise tax.

HB 1101* (Amended HJ 269) authorize municipalities to create programs to encourage housing development.

HB 1033 (Deferred from 17th LD) revise certain provisions concerning elections and election petitions and to declare an emergency.

HB 1025 (Deferred from 17th LD-Removed from Consent Calendar) place certain substances on the controlled substances schedule and to declare an emergency.

HB 1056* (Deferred from 17th LD) revise certain provisions relating to the veterans' preference in employment.

HB 1063 (Deferred from 17th LD) revise provisions regarding required notice of relocation of a minor child when a protection order is in place.
