- HB 1102* allow for additional time to review certain competitive sealed bids.
HB 1108 revise certain municipal special assessment provisions and to provide for exclusion of territory from municipalities.
HB 1117 repeal certain provisions concerning the authorization for the use of other languages in public records or public meetings.

- SB 16* establish a fee for a nursery license and to increase fees for nursery inspection.
SB 69* require accredited schools to accept transfer credits for courses taken by students from other accredited schools during the summer and to declare an emergency.
SB 44* ~~classify vehicular homicide as a crime of violence.~~
create provisions for aggravated vehicular homicide and classify the crime as a crime of violence.
SB 154 provide a penalty for fleeing from a law enforcement officer.
SB 158 revise provisions related to restitution in cases involving juveniles and to declare an emergency.

- SB 133 revise certain provisions regarding shared services provided by the state to school districts, the sharing of services of school district employees, the classroom innovation grant program, and educator mentoring and certification reciprocity.
- SB 152 enact the Peter Falk Act to ensure visitation of certain protected persons.
- SB 159* (Deferred from 24th LD) provide a tax credit to insurance companies that contribute to an organization providing educational scholarships to certain students.

- HB 1007* (Deferred from 24th LD) make an appropriation to revise and update the data and methods used to determine the agricultural land production capacity and to declare an emergency.
- HB 1201* (Deferred from 24th LD) revise the General Appropriations Act for fiscal year 2016, make an appropriation for teen court programs in South Dakota, and to declare an emergency.
- HB 1187 (Deferred from 24th LD) allow the Office of the Secretary of State to refuse to file certain documents.
- HB 1120 (Deferred from 24th LD) revise the definition of agricultural purposes used for the administration of the sales tax.
- HB 1136* (Deferred from 24th LD) ~~revise certain provisions regarding the annual report provided by the Board of Regents to the Council on Higher Education Policy Goals, Performance, and Accountability, and to declare an emergency.~~
eliminate the Council on Higher Education Policy Goals, Performance, and Accountability and to transfer its functions to the Legislative Planning Committee.
