Constitution Art. III, Sec 7: ...The Legislature shall meet...on the second Tuesday of January at 12 o'clock m...

Constitution Art. III, Sec 6: ....regular session of the Legislature...shall not exceed 40 legislative days....

Constitution Art. III, Sec 22: .....no act shall take effect until 90 days after the adjournment of the session...unless in case of emergency.... And, SDCL 2-14-16: ...takes effect on the first day of July....

Constitution Art. IV, Sec 4: .....veto it within 15 days after such adjournment.....
