## **SD Codified Law**

13-3-91. Cardiopulmonary resuscitation to be recommended skill included in school health curriculum. The secretary of education shall annually identify cardiopulmonary resuscitation (CPR) as a recommended skill that all schools should include within school health curriculum and shall inform school districts of resources and training available to assist schools to provide instruction in CPR and the use of automated external defibrillators.

13-3-92. Cardiopulmonary resuscitation training resources. Any training resources the secretary of education recommends pursuant to  $\S$  13-3-91 shall be nationally recognized, use the most current national guidelines for CPR and emergency cardiovascular care, and incorporate psychomotor skills development into the instruction.

13-3-93. Annual survey of cardiopulmonary resuscitation instruction--Report to Legislature. The secretary of education shall electronically survey school districts regarding whether, and to what extent, the instruction of cardiopulmonary resuscitation and the use of automated external defibrillators is offered. The survey must gather data regarding what grades, for what period of time, and in connection with what course of instruction, if any, the training is offered. The secretary shall submit a report of the results of this data collection to the Senate and House standing committees on education and health and human services no later than December 1 of each year. **Source:** SL 2014, ch 79, § 3.

#### **CPR Survey**

On August 18, 2014, an electronic survey was distributed to superintendents and middle/high school principals in South Dakota's public, non-public, and tribal and Bureau of Indian Education-operated schools. The survey requested one response per school district or school system. Per SDCL 13-3-93, the purpose of the survey was to collect data regarding the extent of training related to cardiopulmonary resuscitation (CPR) and the use of automated external defibrillators (AED) offered in schools. The survey closed on October 6, 2014. The results below incorporate responses from 151 public school districts. An additional 50 private and/or BIE schools responded to the survey.

The following charts and graphs represent only public school district results. The survey indicated that 67 or 44% of public school districts are implementing some type of CPR education.

After viewing data from the CPR district survey, the stakeholders' discussions revolved around one solid focus: How to build relationships with districts and offer resources/services to assist them in the training of their students, staff members, and possibly communities overall.

One goal of the committee is to provide their resources to districts to ensure that every student has the opportunity for a minimum of hands-only CPR and AED training. Conversations revealed that there are some miscommunications that should be addressed with districts concerning requirements for CPR certification vs. CPR hands-only/AED training, which non-certified trainers can provide.

An outcome of this discussion was to compile resources for a DOE-sponsored webpage. Resources have been compiled, with a focus on providing school districts access in one location with contact names of organizations across the state, links to national/state organization sites, CPR/hands-only training videos, links to training options, and resource kits for school training sessions. The compiling of valid resources will be an ongoing collaborative effort between the stakeholders noted above, with DOE providing assistance with the webpage hosting.

Notifications of the CPR resources housed on the DOE website will be provided to all schools – public, private and tribal or BIE-operated – through various venues, including DOE's online newsletters, educator listservs, and social media.

## In Progress Action Items

Initially, stakeholders were asked to commit to a one-day meeting; however, this group requested an additional day to continue the discussions, compiling of resources, and organizing regional training opportunities for districts. The stakeholder group members also want to explore funding options to assist with district trainings, resources, training devices, or providing district incentives.

To that end, a second meeting has been scheduled for December 11, 2014. The outcomes will be to organize two regional trainings for districts to attend. Planning will focus on location, dates, funding, and training options ranging from hands-only CPR/AED, to all day CPR/AED certification, mini-sessions encompassing various aspects of CPR training, AED, plus heart disease and prevention. The stakeholders also will need to determine the audience for these trainings:

PE/health teachers, all educators, staff/students, or if community members/leaders should also be included.

DOE will provide assistance with publicity for these regional trainings through the DOE website, online publications, news releases, and social media. DOE also will assist by providing access to its online registration system. Since no funding was designated to support SB 145, DOE will not provide financial assistance for these training sessions.

The website resources will need to be confirmed by the stakeholders group. Once the stakeholders verify the validity of all the sources and contacts, DOE will publish the webpage for viewing with the larger DOE website.
