NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Corrections: Parole Services Division: (January 2, 2009) intends to amend a rule to reflect an increase in assessed supervision fee amounts charged to persons on parole supervision in the State of South Dakota. The general authority for this rule, as cited by the department, is SDCL 24-15-11.3.

A public hearing will be held at 1:00 p.m. on January 30, 2009, in the 3rd floor Conference Room, South Dakota State Penitentiary, Sioux Falls, South Dakota. Copies of the proposed rule may be obtained without charge from and written comments sent to the Parole Division, 1600 North Drive, P.O. Box 5911, Sioux Falls, South Dakota 57117-5911. Written comments must be received by January 29, 2009, to be considered. This hearing is being held in a
