1-26-2012	Transportation	Amend a speed limit on two segments of SD Highway 42 in Minnehaha County from 65 miles per hour to 55 miles per hour; 38 SDR 109.
1-26-2012	Transportation	Amend rules to make farm wineries licensed pursuant to SDCL 35-12-2 eligible for tourist-oriented directional signing in the highway right-of-way under certain conditions; include farm wineries in the definition of "services of motorists;" add farm winery advertising panels into the rules for authorized business signs; and provide minimum eligibility requirements of farm wineries; 38 SDR 121.
