NOTICE OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Bureau of Administration: (January 6, 2016) intends to amend rules to increase the maximum fees chargeable for legal publications required by state law. The general authority for these rules, as cited by the bureau, is SDCL § 17-2-19.

A public hearing will be held in Conference Room #3, in the Kneip Building, Pierre, South

Dakota, on January 29, 2016, at 9:00 a.m. CT. Copies of the proposed rules may be obtained from and written comments sent to the Bureau of Administration, 500 East Capitol, Pierre, South Dakota 57501-1234. Written comments must be received by January 28, 2016, to be considered at the hearing. The deadline for submission of written material is February 10, 2016. This hearing is being held in a physically accessible place. Persons who have special needs for which the office can make arrangements are asked to call (605) 773-3688 at least 48 hours before the hearing.
