REMINDER OF HEARINGS SCHEDULED

1-21-2009	Game, Fish and Parks	Amend a rule to increase boat license fees as follows: (1) for non-motorized boats over 12 feet and boats propelled solely by electric trolling motors – 1 year from \$10 to \$12.50, and 3 years from \$20 to \$25; (2) motorboats under 19 feet – 1 year from \$15 to \$20, and 3 years from \$40 to \$55; and (3) motorboats 19 feet and over – 1 year from \$30 to \$40, and 3 years from \$80 to \$110; 35 SDR 177.
1-30-2009	Corrections: Parole Services Division	Amend a rule to reflect an increase in assessed supervision fee amounts charged to persons on parole supervision in the State of South Dakota; 35 SDR 179.
