### Notice of Proposed Rules

**South Dakota Board of Economic Development (Governor's Office of Economic Development):** (January 16, 2020) intends to amend rules to authorize the Board of Economic Development to make loans from the Revolving Economic Development and Initiative Fund for the construction and refurbishment of multi-family housing; allow for the amortization of loans for multi-family housing for a term of up to 30 years; and repeal a transitional rule adopted in 2007 which is not obsolete. The general authority for these rules, as cited by the board, is SDCL 1-16G-5, 1-16G-8, and 1-16G-28.

A public hearing will be held at the Governor's Office of Economic Development, 711 East Wells Avenue, Pierre, South Dakota, on February 12, 2020, at 9:00 a.m. CT. Copies of the proposed rules may be obtained without charge from and written comments sent to the South Dakota Board of Economic Development, 711 East Wells Avenue, Pierre, South Dakota 57501. All written comments must be received by February 10, 2020, to allow for adequate consideration prior to the hearing. This hearing is being held in a physically accessible location.
