Notice of Proposed Rules: (The date in parentheses is the date the rules were filed with the Legislative Research Council.)

Department of Education: State Library Board: (January 19, 2018) intends to amend rules to clarify language; make consistent with statutory amendments; and remove outdated language from the rules concerning access to public libraries and how certain funding is distributed to public libraries. The general authority for these rules, as cited by the agency, is SDCL § 14-1-59.

committed to ensuring that South Dakotans can live and receive services in the most integrated setting according to the individual's preferences and needs. In an effort to make progress towards this initiative, LTSS is submitting an amendment to the House and Community-Based Options and Person Centered Excellence (HOPE) Waiver which serves South Dakotans age 65 and older as well as individuals over the age of 18 who have a qualifying disability. The purpose of this amendment is to expand and enhance home and community-based services for individuals eligible for the HOPE Waiver.
