NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Health: Board of Massage Therapy: (January 20, 2012) intends to amend rules to eliminate duplication in the complaint process and identify the schools acceptable for licensing applicants. The general authority for these rules, as cited by the board, is SDCL 36-35-12 and 36-35-24.
