Department of Education: Board of Education: (February 5, 2016) intends to adopt Emergency Safety Intervention rules to regulate the use of emergency safety intervention (seclusion and restraint) in schools and require schools to adopt policies and procedures regarding administration, notification, training, and reporting. The general authority for these rules, as cited by the board, is SDCL §§ 13-1-12.1, 13-32-4, 13-37-1.1, 13-37-46, and 13-37-47.

A public hearing will be held at Western Dakota Technical Institute, Dakota Hall Lecture Room, 800 Mickelson Drive, Rapid City, South Dakota, on March 14, 2016, at 10:30 a.m. MT.
