[South Dakota Board of Education Standards \(Department of Education\)](#): (February 6, 2020) intends to amend rules to accurately reflect the federal Individuals with Disabilities Education Act (IDEA) rules amended by the Every Student Succeeds Act (ESSA) and correct the definition of preschool age and preschool program to align with the IDEA preschool age. The general authority for these rules, as cited by the board, is SDCL 13-37-1.1.

A public hearing will be held at the Mitchell Career and Technical Education Academy, Room 10, 821 North Capital, Mitchell, South Dakota, on March 16, 2020, at 9:00 a.m. CT. Copies of the proposed rules may be obtained without charge from and written comments sent to Ferne Haddock, South Dakota Department of Education, 800 Governors Drive, Pierre, South Dakota 57501. Comments may also be emailed to ferne.haddock@state.sd.us. All material sent by mail or email must be received by March 11, 2020, to allow for adequate consideration prior to the hearing. 2-11-2020	<u>February 2020 Rules Hearing</u> : A Supreme Court Rules Hearing will be held in the Courtroom of the Supreme Court, State Capitol, 500 East Capitol Avenue, Pierre, South Dakota on February 11, 2020, at 11:00 a.m. CT. An original and five copies of proposals for amendment or adoption of rules should be filed with the Clerk of the Supreme Court no later than December 6, 2019. Submitters must comply with SDCL 16-3-5.1 when submitting proposals; 46 SDR 57, October 15, 2019.
2-12-2020	<u>South Dakota Board of Economic Development (Governor's Office of Economic Development)</u> : Amend rules to authorize the Board of Economic Development to make loans from the Revolving Economic Development and Initiative Fund for the construction and refurbishment of multi-family housing; allow for the amortization of loans for multi-family housing for a term of up to 30 years; and repeal a transitional rule adopted in 2007 which is not obsolete; 46 SDR 88, January 21, 2020.
3-6-2020	<u>South Dakota Board of Examiners in Optometry (Department of Health)</u> : Amend rules to clarify existing language for release of prescriptions; establish and clarify the process for license renewal and late renewal fees; update and clean up continuing education requirements and documentation; revise requirements of notification of change in professional corporation membership; and add one CPT code to clinical procedures approved for optometrists; 46 SDR 93, January 27, 2020.
