**NOTICE OF PROPOSED RULES:** (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Labor and Regulation: South Dakota Retirement System: (March 11, 2013) intends to amend rules to provide administrative and operational details for a designated Roth contribution program, maintain compliance with federal laws, and make certain terminology and cross reference corrections and clarifications. The general authority for these rules, as cited by the board, is SDCL §§ 3-12-47, 3-12-58, 3-12-76.3, 3-12-89.1, 3-13-54, 3-13-57, and 3-13A-4.

A public hearing will be held at View Thirty Four, 4251 E. Highway 34, Pierre, South Dakota, on April 3, 2013, at 1:00 p.m., CDT. Department of Labor and Regulation: Division of Insurance: (March 12, 2013) intends to amend rules to require equal compensation to producers in certain circumstances; delete provisions relative to refund calculations and to set forth rating standards for health issuers; establish standards for plans filing access plans; establish standards for the sale of individual health insurance outside of an exchange;

establish standards for the sale of employer based health insurance; repeal rules relative to small employer health insurance; set standards for coverage of preventive services; set standards for qualified health plans; and set standards for essential health benefits. The general authority for these rules, as cited by the department, is SDCL §§ 58-4-1, 58-17-4.2, 58-17-64, 58-17-75, 58-17-85, 58-17-87, 58-17F-10, 58-17F-21, 58-18-79, 58-18B-18, 58-18B-20, 58-18B-36, 58-18B-46, 58-30-195, and 58-33A-7.

#### Department of Game, Fish and Parks:

(March 14, 2013) intends to amend a Camping Permits and Rules rule to add Sheps Canyon Recreation Area to the list of areas that require a group lodging fee and establish the fee; amend a Black Hills Elk Hunting Season rule to adjust the number of licenses available for "any elk"

and "antlerless elk"; amend Custer State Park Trophy Bison Bull Harvest rules to change the number of licenses available, modify preference so license applicants accrue an additional preference point for each successive year they are unsuccessful in the draw, change reference from "permit and permit holder" to "license and licensee" and allocate two trophy bison licenses to residents in a first draw with leftover licenses to be available in a second draw for all applicants; amend an Archery Elk Hunting Season rule to adjust the number of licenses available for "any elk" and "antlerless elk"; amend a Prairie Elk Hunting Season rule to adjust the number of licenses available for "any elk" and "antlerless elk", modify Unit 30 (Gregory County) by removing that portion of the unit located in Boyd County, Nebraska, adjust the season dates for Unit 30 (Gregory County) from September 29 - October 28 and December 1 – 31 to September 1 – December 31, adjust the season dates for Unit 11B (Bennett County and portions of Mellette County) from September 1 to the second Sunday of October to September 1 to the Friday before the third Saturday in October, and add Unit 11D (Bennett County and portions of Mellette County) with season dates of September 1 – December 31; and amend Custer State Park Non-Trophy Bison Harvest rules to change the number of licenses and modify preference so applicants accrue an additional point for each successive year they are unsuccessful in the draw and allocate 7 nontrophy bull bison licenses and 5 cow bison licenses to residents in a first draw with leftover licenses after the first draw to be available in a second draw for all applicants; amend a License Forms and Fees rule to increase the license fee for a non-trophy bison bull and a cow bison; and amend a Custer State Park Restrictions rule to add reference to non-trophy bison harvest as seasons in CSP available to non-residents. The general authority for these rules, as cited by the department, is SDCL §§ 41-2-18, 41-6-10, 41-6-18.4, 41-6-19.6, 41-6-21, 41-17-1.1, 41-17-13.4, and 41-17-18.

A public hearing will be held at the Holiday Inn Express, 1360 SD Hwy. 44, Winner, South Dakota, on April 4, 2013, at 2:00 p.m. CDT.
