NOTICE OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Agriculture: Animal Industry Board: (March 21, 2013) intends to amend rules to allow for the use of a blood test to detect bovine tuberculosis in elk, red deer, white-tailed deer, fallow deer and reindeer and change and update current dates of reference material. The general authority for these rules, as cited by the board, is SDCL §§ 40-3-14, 40-3-25, 40-3-26, and 40-5-8.6.

A public hearing will be held at the Animal Industry Board Office, 411 South Fort Street, Pierre, South Dakota, on April 23, 2013, at 9:30 a.m. Copies of the proposed rules may be obtained without charge from and written comments sent to the South Dakota Animal Industry Board Office, 411 South Fort Street, Pierre, South Dakota 57501. Material sent by mail must reach the Board Office by April 22, 2013, to be considered. This hearing is being held in a physically accessible place.
