NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Commerce And Regulation: Board of Nursing and Joint Board of Nursing and Board of Medical and Osteopathic Examiners: (March 26, 2003) intends to adopt rules that will raise the licensure fees charged for all categories of nurse licensure; RN, LPN, Clinical Nurse Specialist, Certified Registered Nurse Anesthetist, Certified Nurse Practitioners, and Certified Nurse Midwives. The general authority for these rules, as cited by the department, are SDCL 36-9-21, 36-9-91, and 36-9A-26.

A public hearing will be held at 9:00 a.m. CST on April 23, 2003, via the Digital Dakota Network (DDN) at Southeast Technical Institute, Mickelson Education Center, Room 205, 2301 Career Place, Sioux Falls, South Dakota and at the DDN at Rapid City Regional Hospital, Education Services Department, 353 Fairmont Blvd., Rapid City, South Dakota. Department of Health: (March 28, 2003) intends to adopt rules to clarify the types of professionals eligible for the Health Professional Recruitment Incentive Program, and the process used to select applications. The

general authority for these rules, as cited by the department, is SDCL 1-16A-73.18.
