NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Revenue and Regulation: Division of Banking: (March 29, 2004) has filed rules to adopt an examination fee for trust company examinations and a licensing fee for money order businesses, amend the license fee rates for mortgage brokers, mortgage bankers, and money lending businesses. The general authority for these rules, as cited by the department, is SDCL 51A-2-33, 51A-6A-36, 51A-16-9, 54-4-40, 54-4-45, and 54-14-10.

A public hearing will be held in Room 412 of the Capitol, 500 East Capitol Avenue, Pierre, South Dakota, on April 20, 2004, at 10:00 a.m. Copies of the proposed rules may be obtained from and written comments sent to the Department of Revenue and Regulation, Legal Services, 445 East Capitol Avenue, Pierre, South Dakota 57501-3185, or by emailing Beth.Christie@state.sd.us. Copies of the rules are also available at the department's website: www.state.sd.us/drr. Material sent by mail must reach the department by April 19, 2004, to be considered. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-4701 at least 48 hours before the hearing.

Department of Social Services: Office of Medical Services: (March 29, 2004) has filed rules to: incorporate by reference the latest federal poverty levels; remove the requirement that pregnancy be verified by a licensed medical professional before a woman may be eligible for

certain medical programs; provide medical coverage for children under age 21 who were in foster care under the responsibility of the state on their 18th birthday; provide medical services for certain women who have been diagnosed with breast or cervical cancer by the Department of Health; specify that individuals applying for or receiving medical assistance must avail themselves of all income and resources to which they are entitled; specify that medical assistance paid in error is subject to recovery by the department; when determining if an individual meets the residency requirements for long-term care assistance, specify that the individual must be in a licensed hospital, nursing facility, intermediate care facility, or assisted living facility that has a Medicaid provider agreement with the department for the level of care and services provided or must reside in an adult foster care facility licensed by the South Dakota Department of Health; consider that the required 30-consecutive-day period of institutionalization has been met if the individual is otherwise qualified but dies before the 30th consecutive day; when determining eligibility for long-term care or medical assistance, exempt from consideration as income certain payments made by the Veterans' Administration, payments to volunteers under the National and Community Services Trust Act of 1993, AmeriCorp VISTA, RSVP, senior companion program, Agent Orange product liability settlement, a gift from a tax-exempt organization to a minor child who has a life-threatening condition, a hemophilia settlement fund payment, income of an SSI recipient that is used toward an SSI approved plan for achieving self-support, income provided to victims of a presidentially-declared disaster from federal, state, and local programs and agencies, and income placed into certain

trusts; when determining eligibility for longterm care or medical assistance, consider as income the interest earned on unspent, previously excluded income; establish provisions for the consideration of income and resources for a child born in a hospital and continuously hospitalized for 30 or more consecutive days from the date of birth; establish provisions for the consideration of income and resources for a married couple when only one spouse participates in either HCBS (Home- and Community-Based Services) or HCBWS (Home- and Community-Based Waivered Services); increase the SSI standard benefit amount; repeal a rule pertaining to assets transferred for less than fair market value prior to July 1, 1994; for an applicant or recipient of long-term care, consider the value of real or personal income-producing property; when specifying the requirements that a Medicaid trust must meet, delete the term "long-term care" and use instead "nursing facility, HCBS, or HCBWS"; determine an applicant or recipient to be resource-eligible for an entire month if the applicant's or recipient's resources are within the established limit at some time during the month; clarify that the assessment of a community spouse's share of resources does not apply to individuals entering either an assisted living or an adult foster care facility; when determining initial eligibility for longterm care assistance, clarify that the deduction of the community spouse's share of resources from the couple's total countable resources is allowed only if the institutionalized spouse is receiving HCBS or is in a nursing or intermediate care facility; limit eligibility for the Renal Disease Program to individuals who have been on dialysis for one month or have received a transplant within the last 12 months; require an individual applying for benefits under the Renal Disease Program to be a U.S. citizen or a qualified alien; specify that the department does not consider Indian Health Services or, in certain instances, the department to be a thirdparty payer for purposes of the Renal Disease Program; delete as a covered benefit under the Renal Disease Program the payment of

Medicare Part B premiums for certain Medicare recipients; increase the rate of payment for travel expenses reimbursable under the Renal Disease Program; and correct an internal reference. The general authority for these rules, as cited by the department, is SDCL 25-4-45.3, 28-1-61, 28-6-1, 28-6-3.1, 28-6-18, 28-6A-12, 28-7A-3, and 28-7A-24.

Ms. Wellhouse may be contacted by telephone at (605) 773-3305. Written comments must be received by April 29, 2004, to be considered. Individuals intending to present oral testimony at the hearing must make a written copy of their testimony available to the department at the time of the hearing. The testimony must relate directly to the changes being proposed and must cite the specific rule number to which the comments are being directed. This hearing is being held in a physically accessible place. Department of Agriculture: Division of Agricultural Services: (March 30, 2004) has filed rules to adopt the changes to the 2003 Pasteurized Milk Ordinance (PMO) that was passed at the 2003 National Conference of Interstate Milk Shippers. The general authority for these rules, as cited by the department, is SDCL 39-6-9.

Department of Revenue and Regulation:

(April 2, 2004) intends to amend rules to impose municipal rate changes on sales by catalog companies that publish local rates in their catalogs to the first day of a calendar quarter after 120 days notice has been given to the seller; complete an annual update by changing the year referred to in these rules and an address for filing; change the capitalization factor used to determine the capitalized income value; provide two separate methods for sellers to compute the tax due on a transaction, and to allow for the use of a rounding rule; clarify definitions; explain what portion of the delivery charge is taxable when both taxable and nontaxable products are sold in one transaction;

update rules after the repeal of the tax on transportation; clarify when a manufactured home can be treated as a sectional home for tax purposes; change when the contractors' excise tax applies to manufactured buildings. The general authority for these rules, as cited by the department, is SDCL 10-1-16.1, 10-3-1.2, 10-45-47.1, 10-45-108, 10-46-35.1, and 10-52-4.
