FILINGS IN THE LEGISLATIVE RESEARCH COUNCIL'S OFFICE:

Notice of Proposed Rules: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Game, Fish, and Parks: (June 19, 2017) intends to amend a Custer State Park Restrictions rule to amend the 200 yard hunting restriction near roads and buildings within Custer State Park presently applicable to big game species to include coyotes; amend a Sage Grouse Hunting Season rule to close the season; amend an Antelope Hunting Season rule to adjust the number of hunting licenses; amend a Custer State Park Antelope Hunting Season rule to close the season; and amend Custer State Park Coyote Hunting Season rules to reopen the coyote hunting season, adjust the season dates from the second Monday in December to December 31, inclusive, to December 26 to March 31, inclusive, allow any resident possessing a valid resident predator/varmint license, resident furbearer license, or any resident hunting license to hunt coyotes in the Custer State Park hunting unit (Unit CUC-CU1), and require a hunter to obtain and possess a free access permit issued by the department in order to hunt coyotes in Custer State Park. The general authority for these rules, as cited by the department, is SDCL §§ 41-2-18, 41-11-5, and 41-17-1.1.

A public hearing will be held at the AmericInn, TeTon Conference Center, 312 Island Dr., Ft. Pierre, South Dakota, on July 13, 2017, at 2:00 p.m. CDT. Copies of the proposed rules may be obtained from and written comments sent to the office of the Secretary of the

Executive Order:

The Governor has signed **Executive Order 2017-06** dated June 16, 2017. This order declares a state of emergency to exist due to widespread drought conditions, low humidity, and high temperatures in the state of South Dakota. This order declares that a state of drought emergency exists and that the following administrative rules are hereby suspended: ARSD 70:04:06:06 - prohibiting the mowing of the right-of-way east of the Missouri River before July 10th and ARSD 61:25:02:01 - limiting the farm vehicle operators commercial driver's license exemption to within 150 miles of a person's farm. This order shall expire on

December 16, 2017. A copy of the Executive Order is available from the Secretary of State's office.
