NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Transportation: (June 29, 2009) is proposing to amend a speed zone in Meade County on South Dakota Highway 79 north of Sturgis to reduce the speed limits on a segment of highway north of Highway 34 during the first two weeks of August. The general authority for this rule, as cited by the department, is SDCL 32-25-7.

A public hearing will be held in the Commission Room of the Becker Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota, on July 23, 2009, at 9:05 a.m. CDST. Copies of the proposed rule may be obtained without charge from and written comments sent to the Secretary of Transportation, Becker-Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota 57501-2586. Material sent by mail must reach the department by July 22, 2009, to be considered. This hearing is being held in a physically accessible place. NOTICE:

The **Department of Social Services** is proposing to revise the South Dakota Medicaid State Plan concerning reimbursement methodology for nursing facilities and inpatient hospital. The proposed State Plan Amendments (SPAs) have an effective date of July 7, 2009. SPA 09-5 pertains to inpatient hospital, and SPA 09-6 pertains to nursing facilities. The

proposed changes amend Attachments 4.19-A and 4.19-D of the State Plan to remove the 3% inflationary increase in target amounts for inpatient hospital and allowable costs for nursing facilities that are used in calculating reimbursement rates, pursuant to legislative appropriations. The Federal fiscal impact associated with these amendments is a reduction of \$684,709 for Federal Fiscal Year 2009 and a reduction of \$2,054,128 for 2010 for nursing facilities, and a reduction of \$499,676 for Federal Fiscal Year 2009 and reduction of \$1,499,029 for 2010 for inpatient hospital. Copies of the proposed SPAs are available at the Department of Social Services, Division of Medical Services. Changes include amending existing requirements for recycling; clarification of compliance monitoring requirements for hazardous waste combustion operations; and amending requirements for the management of wastewater treatment sludges generated by automobile assembly operations; 35 SDR 352.
