Department of Health: Board of Chiropractic Examiners: (July 7, 2008) intends to amend and adopt rules to clarify requirements for declaratory rulings; approve accreditation from the Council of Chiropractic Education International; update application and reciprocity requirements; update renewal application requirements; update actions which may warrant sanctions; clarify procedures for formal hearings and sanctions; clarify chiropractic radiography application process and procedures for formal hearing; update addresses to obtain peer review reference guides; and establish rules for chiropractic assistants. The general authority for these rules, as cited by the board, is SDCL 36-5-2.2, 36-5-4, 36-5-13, 36-5-15.2, 36-5-15.3, 36-5-16, 36-5-16.1, 36-5-19, 36-5-20, 36-5-21, 36-5-24, 36-5-25, 36-5-27, and 36-5-28.
