NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Labor and Regulation: Banking Commission and Division of Banking:

(July 16, 2012) intends to amend rules to clarify the types of mutual funds that may be invested in or held by banks chartered and regulated by the Division of Banking; increase the annual asset based supervision fee paid by state-chartered trust companies and to establish a separate minimum and maximum fee amount payable by private and public trust companies; amend the trust administration duties that must be done in South Dakota by public trust companies to comply with a statutory requirement; repeal an unnecessary proof of experience requirement for certain mortgage license applicants; and remove unnecessary transition language related to continuing education requirements. The general authority for these rules, as cited by the department, is SDCL §§ 51A-2-13, 51A-4-25, 51A-2-36, 51A-6A-11.1, 51A-6A-33, 54-14-22, and 54-14-31.
