NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Education: Board of Education: (August 2, 2012) intends to amend rules to implement a new accountability system for South Dakota's public schools, in light of the waiver releasing South Dakota from certain provisions of No Child Left Behind. The general authority for these rules, as cited by the board, is SDCL §§ 13-3-48, 13-3-51, 13-3-55, 13-3-62, 13-3-64, 13-3-66, 13-3-67, 13-3-69, and 13-42-33.

A public hearing will be held at the MacKay Building Board Room, Second Floor, 800 Governors Drive, Pierre, South Dakota, on August 23, 2012, at 11:00 a.m. CT.
