NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council)

Department of Transportation: (September 17, 2002) intends to adopt rules to amend speed zones in Hand County and to establish spacing and location criteria for permitting the construction of approaches onto state highways. The general authority for these rules, as cited by the department, is SDCL 11-3-12 and 32-25-7.

A public hearing will be held in the Commission Room, Becker-Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota, on September 26, 2002, at 9:05 a.m. Copies of the proposed rules may be obtained from and written comments sent to the Secretary of Transportation, Room 202, Becker-Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota 57501-2586. Written comments must be received by September 25, 2002, to be considered. This hearing is being held in a physically accessible place.
