NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council)

Bureau of Information and

Telecommunications: (September 19, 2001) is proposing rules to provide specifications for state agency use of electronic signatures and transactions. The general authority for these rules, as cited by the bureau, is SDCL 53-12-47.

A public hearing will be held in Conference Room 3, Kneip Office Building, 700 Governors Drive, Pierre, South Dakota, on Tuesday, October 16, 2001, at 1:15 p.m. Copies of the proposed rules may be obtained from and written comments sent to Jan Newman, Bureau of Information and Telecommunications, 1017 18th Street NE, Watertown, South Dakota 57201. Ms. Newman may be contacted by telephone at (605) 882-5711. Written comments must be postmarked by October 26, 2001, to be considered. This hearing is being held in a physically accessible place. Persons who have special needs for which the bureau can make arrangements are asked to call (605) 882-5711 at least forty-eight hours before the hearing.

Department of Social Services: (September 21, 2001) intends to adopt a rule under the authority of the Food Stamp Act of 1977, which establishes the parameters under which the Food and Nutrition Service (FNS) sets the monthly gross and net income eligibility standards for food stamp households based on the established thrifty food plan. The FNS will no longer publish in the Federal Register the annual updates to the monthly gross and net income eligibility standards, the maximum food stamp allotment, and the thrifty food plan. Effective

with the publication of the October 30, 2000 Federal Register, the FNS will notify states of the annual updates with a policy memo on the FNS web site at www.fns.usda.gov/fsp. These limits are effective October 1, 2001.
