NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

***Department of Revenue and Regulation:
Appraiser Certification Program:***

(November 7, 2007) intends to amend rules to adopt the most recent edition of the uniform standards and add grounds for disciplinary action for failure to comply with a Final Order issued by the secretary. The general authority for these rules, as cited by the department, is SDCL 36-21B-3.

A public hearing will be held in the Department of Revenue and Regulation First Floor Conference Room, Anderson Building, Pierre, South Dakota, on December 17, 2007, at 10:30 a.m. A copy of the proposed rules may be obtained from and written comments sent to the Department of Revenue and Regulation, Appraiser Certification Program, 445 East Capitol Avenue, Pierre, South Dakota 57501-3185. Material sent by mail must reach the department by December 14, 2007, to be considered at the public hearing. The department will keep the comment period open until December 27, 2007, for written comments. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-4608 at least 48 hours before the hearing.

FILINGS IN THE SECRETARY OF STATE'S OFFICE:

Executive Orders:

The Governor has signed **Executive Order 2007-24** dated November 8, 2007, which creates the Governor's Interagency Council on Homelessness to work with the United States Interagency Council on Homelessness. This order supersedes Executive Order 2003-07 dated September 25, 2003.

The Governor has signed **Executive Order 2007-25** dated November 8, 2007, which declares that a state of emergency exists statewide, and that the transportation of diesel, ethanol, gasoline and propane within South Dakota shall be exempt from 49 CFR Part 395, otherwise known as the federal hours of service regulations. The executive order shall expire upon conclusion of the emergency, but no later than midnight, December 7, 2007.

The Governor has signed **Executive Order 2007-26** dated November 8, 2007, which creates the South Dakota Commission on Child Support. SDCL 25-7-6.12 requires the state to establish a State Commission on Child Support to review child support guidelines. The commission members will include a noncustodial parent, a custodial parent, a representative from the judiciary, a representative from the Department of Social Services, and a family law practitioner. The Commission will submit a report to the Governor and the Legislature before December 31, 2008.

11-19-2007	Education: Board of Education	Amend a rule to change the April 1 st timeline for applications for new or expanded postsecondary programs; 34 SDR 135.
12-17-2007	Revenue and Regulation: Appraiser Certification Program	Amend rules to adopt the most recent edition of the uniform standards and add grounds for disciplinary action for failure to comply with a Final Order issued by the secretary; 34 SDR 139.
