Department of Environment and Natural Resources: Water Management Board: (November 16, 2009) intends to amend Drinking Water Standards rules to incorporate by reference the most recent published version of the Code of Federal Regulation for drinking water. Additional sections of federal rules associated with the Ground Water Rule, Stage 2 Disinfection By-Product rule, Long Term 2 Enhanced Surface Water Treatment rule, and the minor revisions to the Lead and Copper rule will be added. The general authority for these rules, as cited by the department, is SDCL 34A-3A-3.
