**Notice of Proposed Rules:** (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

**Department of Transportation:** (November 22, 2016) is proposing to amend a Tripp County speed zone rule by reducing a speed limit from 65 mph to 45 mph on U.S. Highway 183 beginning at its junction with U.S. Highway 18 in Colome, then south for 0.5 mile. The general authority for this rule, as cited by the department, is SDCL § 32-25-7.

A public hearing will be held in the Commission Room, Becker-Hansen Building, 700 East Broadway, Pierre, South Dakota, on December 20, 2016, at 9:30 a.m. CT.
